The undersigned does hereby irrevocably appoint the said Ba 12 the agent of the undersigned for the management of said property, and does hereby authorize the Bank to let and re-let said premises or any part thereof, according to its own discretion, and to bring or defend any suits in connection with said premises in its own name or in the name of the undersigned, as it may consider expedient, and to make such repairs to the premises as it may deem proper or advisable, and to do anything in or about said premises that the undersigned night do, hereby ratifying and confirming anything and everything that the said Bank may do.

It is understood and agreed that the said Bank shall have the power to var and apply said avails, issues and profits toward the payment of any present or future indebtedness or liability of the unforsigned to the said Bank, due or to become due, or that may hereafter be contracted, and also toward the payment of all expenses for the care and management of said premises, including taxes, insurance, assessments, usual and customa y commissions to a real estate broker for leasing said premises and collecting rents and the expense for such attoriess spents and servants as may reasonably be necessary.

It is understood and agreed that the Bank will not exercise its rights under this Agreement until after default in

any payment secured by the Mortgage or after a breach of any of its covenants.
