No policy of insurance required hereunder shall contain deductible provisions which have not been approved by Mortgagee. In addition to the insurance coverage, hereinabove required, Mortgagor shall maintain loss of rents insurance in an amount equal to not less than one hundred rents insurance in an amount equal to not less than one hundred percent (100%) of the annual gross rental of the Premises based on one hundred percent (100%) coccupancy. Mortgagor shall not carry separate insurance concurrent in kinds or form and contributing in the event of loss, with any insurance required hereby lortgagor shall also obtain and maintain public liability, properly damage and workmen's compensation insurance, in each case, in form and content satisfactory to Mortgagee and in amounts as are customerily carried by owners of like property and as approved by Mortgage. - 3. No Removal. - 4. A coleration. - 6. Payment of Impositions. That the Mortgagor will pay all taxes, assessments, water rates, sewer rents, gas, electric and all other charges ordinary and extraordinary of every kind and nature whatsoever and any prior and junior liens now or hereafter assessed or liens on or levied against the Premises or any part thereof, and in case of default in the payment thereof when the same shall be due and payable, it shall be lawful for the Mortgagee, without notice or demand to the Mortgagor, to pay the same or any of them; that the moneys paid by the Mortgagee in discharge of taxes, assessments, water rates, sewer rents and other charges and liens shall be a lien on the Premises added to the amount of said Note and secured by this Mortgage, payable on demand, together with any sums paid by Mortgagee to keep the Premises in a clean and healthy condition as required herein, with interest at the Default Rate; and that upon request of the Mortgagee, the Mortgagor will exhibit to the Mortgagee receipts for the payment of all items specified in this Article prior to the date when the same shall become delinquent.
- 7. Appointment of Receiver.
