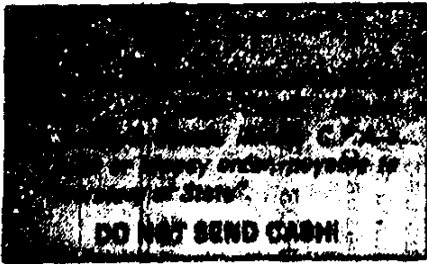

FEE SCHEDULE

- The filing fee is \$75.00
