#### SECOND MODIFICATION AGREEMENT

THIS AGREEMENT is made as of this 1500 day of January, 1990, by and between American National Bank and Trust Company of Chicago, not personally, but solely as Trustee u/t/a dated December 15, 1988, a/k/a Trust Number 106402-09 ("Borrower"), American National Bank and Trust Company of Chicago, a national banking association ("Lender"), Roselle Towne Square Limited Partnership, an Illinois limited partnership (the "Partnership") and William A. Shiner ("Guarantor").

WHEREAS, Lenier made a construction loan (the "Loan") to American National Bank and Trust Company of Chicago, not personally, but solely as (rustee u/t/a dated January 13, 1988, a/k/a Trust No. 104439-01 (the "Original Borrower") pursuant to a Construction Loan Agreement dated April 15, 1988, by and among Lender, Original Borrower and the Partnership (the "Loan Agreement"); and

WHEREAS, pursuant to the Loan Agreement, the Original Borrower executed a Construction Fortgage dated April 15, 1988 and recorded in the Office of the Cook County Recorder of Deeds (the "Recorder") as Document Number 8/1257943 (the "Mortgage") to secure a note executed by the Original Forware in the principal amount of Three Million Three Hundred Thousand Dollars (\$3,300,000) (the "Note"); and

WHEREAS, pursuant to the Loan Agreement, Guarantor executed and delivered to Lender a Guaranty of Payment and Performance, dated April 15, 1988 (the "Guaranty"); and

WHEREAS, by Modification Agreement dated October 24, 1988, and recorded in the Office of the Recorder as Document Number 89018995 (the "Modification Agreement"), and by Assumption Agreement dated December 30, 1988 (the "Assumption Agreement"), and recorded in the Office of the Recorder as Document Number 89582865. Borrower assumed all of the Original Borrower's liabilities under the Loan Agreement, the Note and the Mortgage; and

WHEREAS, the Modification Agreement increased the amount of the Note to Three Million Five Hundred Thousand Dollars

WHEREAS, pursuant to the Assumption Agreement, the Partner-ship and Guarantor affirmed the terms of the Loan, as modified; and

WHEREAS, Lender has agreed to advance an additional One Hundred Thousand Dollars (\$100,000) to the Partnership and Borrower in accordance with the Loan Agreement; and

Whereas, the parties wish to modify the Loan Agreement, the Note, the Mortgage, the Guaranty and other Loan Documents (as defined in the Loan Agreement) to reflect the increased loan amount.

NOW THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. The foregoing Recitals are incorporated herein and by this reference made a part hereof.
- 2. The maximum principal amount available to the Partnership under the Loan Agreement is hereby increased to Three Million Six Hundred Thousand Dollars (\$3,600,000) (the "New Loan Amount").
- 3. The principal amount payable under the Note is hereby increased to the New Loan Amount, or so much thereof as may be disbursed from time to time.
- 4. The Maturity Date of the Note is hereby extended until July 31, 1990.
- 5. The principal amount secured by the Mortgage is hereby increased to the New Loan Amount.
- 6. Guarantor acknowledges and agrees that the principal of amount guaranteed by Guarantor pursuant to Guaranty of Payment and Performance dated April 15, 1988 (the "Guaranty") is hereby increased to the New Loan Amount.
- 7. All other Loan Documents securing the Loan, including Collateral Assignment of Leases and Rents, dated April 15, 1988, (the "Assignment of Leases") are hereby amended to reflect that they are security for the New Loan Amount.
- 8. Except as amended hereby, and as amended by the Modification Agreement, the Loan Agreement, the Note, the Mortgage, the Guaranty, the Assignment of Leases and Rents and all other
