AN ORDINANCE
ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF PALATINE
907 DORSET AVENUE (PROPERTY SOUTH OF THE DORSET AVENUE
RIGHT-OF-WAY; BOUNDED BY THE WHYTECLIFF SUBDIVISION ON THE
WEST, THE ABBEY HILL SUBDIVISION ON THE EAST, AND THE CAM-
BRIDGE HEIGHTS SUBDIVISION ON THE SOUTH) AND 974 W. DORSET

WHEREAS, the Owners of record of the following
described territory have petitioned that said territory be
annexed to the Village of Palatine, Illinois, and

WHEREAS, the Municipal Authorities find and have
determined that said territory is contiguous to the Village
of Palatine, and

WHEREAS, the Palatine Rural Fire Protection District
has been duly notified in writing more than ten (10) days in
advance of consideration of this ordinance, pursuant to
statutes:

90090243 NOW, THEREFORE, BE IT ORDAINED, by the President and
Board of Trustees of the Village of Palatine, acting in the
exercise of their home rule power:

SECTION 1: That the following territory:

Lot 25 in Arthur T. McIntosh and Company's Quintens
Road Farms; being a subdivision of the west 90 acres of
the southwest quarter of Section 22, Township 42 North,
Range 10 east of the Third Principal Meridian; also the
Northeast quarter of the Southeast quarter of Section
21, Township 42 North, Range 10 East of the Third
Principal Meridian;

ALSO
Lot 5 in Block 15 in Arthur T. McIntosh and Company's
Palatine Hills, being a subdivision of part of the East
half of the Northeast quarter of Section 20, township
42 North, Range 10 East of the Third Principal
Meridian;

ALSO
All of Dorset Street lying North of and adjoining said
Lot 25 in Arthur T. McIntosh and Company's Quintens
Road Farms aforesaid, and all of Middleton Avenue lying
West of and adjoining said Lot 5 in Arthur T. McIntosh
and Company's Palatine Hills aforesaid, all in Cook
County, Illinois

commonly known as 907 Dorset Avenue (property south of
the Dorset Avenue right-of-way; bounded by the
Whytecliff Subdivision on the West, the Abbey Hill
Subdivision on the east, and the Cambridge Heights
Subdivision on the south) and 974 W. Dorset.

SECTION 3: That all ordinances or parts of ordinances in conflict with this ordinance be and the same are hereby repealed.


SECTION 4: That this ordinance shall be in full force and effect after its passage and approval as provided by law.
