This Home Equity Line of Credit Mortgage is made this 12th day of February, 19 90, between the Mortgagor, (herein "Borrower"), and the Lender, Glenwood Bank, an Illinois banking corporation whose address is 18301 S. Halsted Street, Glenwood, Illinois 60425 (herein "Lender").

WITNESSETH:

WHEREAS, Borrower and Lender have entered into a Glenwood Bank Home Equity Line of Credit Agreement and Disclosure Statement (the "Agreement") dated February 12, 19 90, to which Borrower may from time to time until February 12, 2000, borrow from Lender sums which shall not in the aggregate outstanding principal balance exceed \$ 26,000.00, the ("Maximum Credit") plus interest. Interest on the sums borrowed pursuant to the Agreement is payable at the rate and at the times provided for in the Agreement. After February 12, 2000, (i) all sums outstanding under the Agreement may be declared due and payable or (ii) all sums outstanding under the Agreement and all sums borrowed after such date, together with interest thereon, may be due and payable on demand. All amounts borrowed under the Agreement plus interest thereon must be repaid by February 12, 2000 (the "Final Maturity Date").

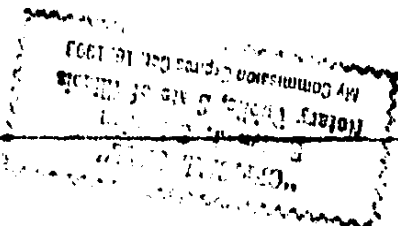
