Nothing herein or in said Trust Deed or Mortgage, or any of the covenants contained therein shall be construed as creating any liability of LaSalle National Bank personally to pay the said Note or Note security or bond that may accrue thereon or any indebtedness accruing thereunder or hereunder, or to perform any agreement or covenant either express or implied herein or therein contained, all such liability, if any, being expressly waived by Assignee and by anyone hereof hereafter, jointly and severally, insofar as LaSalle National Bank, personally, is concerned. The Assignee hereunder or the legal holder or holders thereof shall be, for and to the use and benefit of any mortgagee, lienholder or creditor, any and all claims hereunder shall be paid to the mortgagee, lienholder or creditor and to the extent hereof assigned for the payment thereof, by the enforcement of the lien hereof and by said Trust Deed or Mortgage, created in the manner herein and in said Trust Deed or Mortgage and Note as provided.

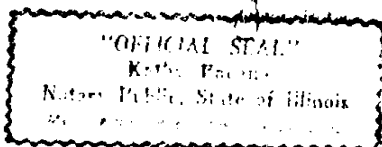
