## TENTE AMENDMENT TO DECLARATION OF CONDONINIUM OWNERSHIP FOR

THIS TENTH AMENDMENT is made and entered into by the Carriage Way of Burr Ridge Condominium Association ("Association").

#### WITHESSETE

WHEREAS, pursuant to the provisions of a certain Declaration of Condominium Ownership for Carriage Way of Burr Ridge Condominium, Burr Ridge, Illinois ("Declaration"), recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document Number 87607850, AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, a national banking association not individually but as Trustee under Trust Agreement dated May 4, 1987 and known as Trust No. 102386-08 submitted certain real estate to the Condominium Property Act of the State of Illinois; and said real estate and the improvements situated thereon are commonly known as Carriage Way of Burr Ridge Condominium in Burr Ridge, Illinois; and

WHEREAS, the Declaration was previously amended by a First Amendment thereto which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 88107667; by a Second Amendment thereto which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois, as Document No. 88107668; by a Third Amendment thereto which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois, as Document No. 88107669; by a Fourth Amendment thereto which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois, as Document No. 88114723; by a Fifth Amendment thereto which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 88249207; by a Sixth Amendment thereto which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 88287032; by a Seventh Amendment thereto which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 88338361 and by an Eighth Amendment thereto which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document 88465605 and by a Ninth Amendment thereto which was recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 89131398; and

WHEREAS, pursuant to the provisions of the Declaration, the Association desires to further exend the Declaration as hereinafter set forth; and

WHEREAS, this amendment has heretofore been approved by all of the members of the Association's Board of Directors.

NOW, THEREFORE, the Association does hereby amend the Declaration as follows:

1. The first sentence of Section 4 of Sub-Article III of Article 2 of the Declaration is amended to read as follows:

"Meetings of the Voting Members shall be held at the Property or at such other place in Cook or DuPage County, Illinois, as may be designated in any notice of a meeting."

2. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
