- The registered office must include a street or road address, a post office box number alone is not 2. acceptable.
- A corporation cannot act as its own registered agent. 3.
- If the registered office is changed from one county to another, then the corporation must file with 4. the recorder of deads of the new county a certifled copy of the articles of incorporation and a certified copy of the statement of change of registered office. Such certified copies may be obtained ONLY from the Secretary of State.
- Any change of registered again must be by resolution adopted by the board of directors. This statement must then be signed by the Fresident (or vice-president) and by the Secretary (or an assistant secretary).
- The registered agent may report a charge of the registered office of the corporation for which he 6. or she is registered agent. When the agent poorts such a change, this statement must be signed by OUNT CO the registered agent.
