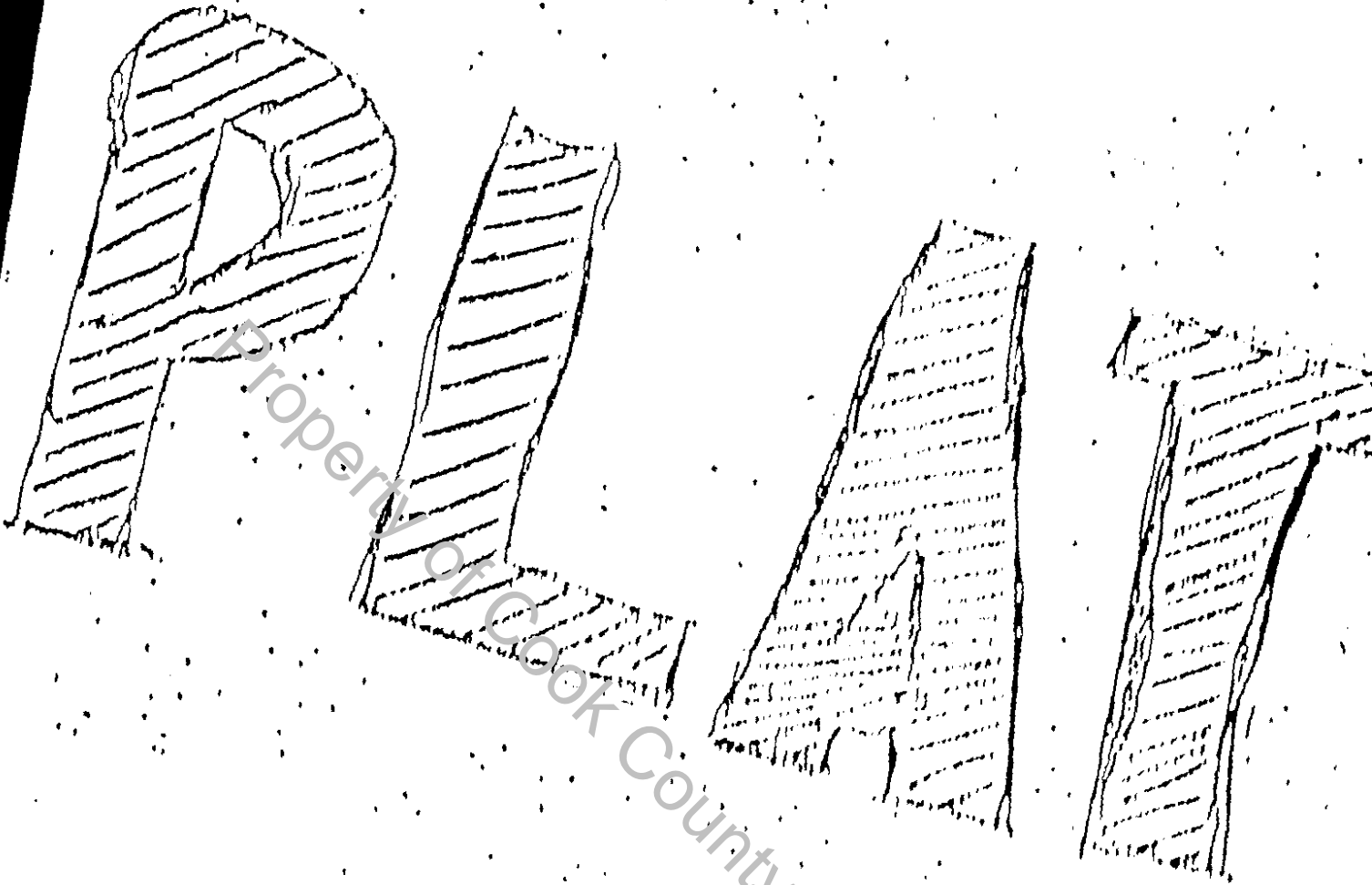

ORDINANCE NO. 1419

AN ORDINANCE
ANNEXING CERTAIN TERRITORY
TO THE VILLAGE OF MATTESON,
COOK COUNTY, ILLINOIS, PURSUANT
TO CHAPTER 24, SECTION 7-1-10 OF THE
ILLINOIS REVISED STATUTES, AS AMENDED.

WHEREAS, the hereinafter described territory is contiguous to the existing Village limits of the Village of Matteson; and

WHEREAS, the hereinafter described territory is dedicated and used for street and/or highway purposes and no part of the said territory is within any other municipality; and

WHEREAS, it is in the best interests of the Village of Matteson that said territory be annexed to the Village of Matteson; and

WHEREAS, all of the requirements of Chapter 24, Section 7-1-10 and all other necessary legal requirements of the statutes of the State of Illinois have been complied with.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Matteson, Cook County, Illinois, as follows:

Section 1. That the following described territory:

The South 70.00 feet of the Northeast 1/4 lying West of the West line of the East 400.00 feet of the West 1/2 of the East 1/2 of the said Northeast 1/4 of Section 20, Township 35 North, Range 13 East of the Third Principal Meridian; the North 70.00 feet of the Southeast 1/4 lying West of the Southerly extension of the West line of the East 400.00 feet of the West 1/2 of the East 1/2 of the said Northeast 1/4, (except the South 9.00 feet of the East 50.00 feet of the West 169.15 feet of the said North 70.00 feet), of Section 20, Township 35 North, Range 13 East of the Third Principal Meridian; the South 70.00 feet of the Northwest 1/4 and the North 70.00 feet of the Southwest 1/4 of Section 20, Township 35 North, Range 13

East of the Third Principal Meridian; the South 70.00 feet of the East 1451.00 feet of the Northeast 1/4 and the North 70.00 feet of the East 1451.00 feet of the Southeast 1/4 of Section 19, Township 35 North, Range 13 East of the Third Principal Meridian; also a part of Section 19, Township 35 North, Range 13 East of the Third Principal Meridian, said part being a 140.00 feet wide parcel of land, the center line of said parcel being a line drawn from a point on the East-West centerline of said Section 19, said point being 1451.00 feet West of the East Quarter corner of said Section 19, to a point on the West line of said Section 19, said point being 12.66 feet North of the West Quarter corner of said Section 19, (excepting from said 140.00 feet wide parcel the Westerly 70.00 feet thereof lying North and South of the East-West center line of Section 19 and also excepting from said 140.00 feet wide parcel, the Northerly 7.00 feet thereof that falls within the East 78.45 feet of the West 202.45 feet of the East 1/2 of the Northwest 1/4 of said Section 19), all in Cook County, Illinois.

being indicated on an accurate map of the above annexed territory, as shown on the Plat of Annexation prepared by Joseph M. Decraene which is appended to and made a part of this ordinance, is hereby annexed to the Village of Matteson, Cook County, Illinois.

Section 2. That the Clerk of the Village of Matteson is hereby directed to record with the Recorder of Deeds of Cook County and the Cook County Election Authority a certified copy of this Ordinance, together with the accurate map of the territory annexed appended to said Ordinance.
