ORDINANCE NO. 1419

AN ORDINANCE
ANNEXING CERTAIN TERRITORY
TO THE VILLAGE OF MATTESON,
COOK COUNTY, ILLINOIS, PURSUANT
TO CHAPTER 24, SECTION 7-1-10 OF THE
ILLINOIS REVISED STATUTES, AS AMENDED.

VHEREAS, the hereinafter described territory is contiguous to the existing Village limits of the Village of Matteson; and

whereas, the hereinafter described territory is dedicated and used for street and/or highway purposes and no part of the said territory is within any other municipality; and

WHEREAS, it is in the best interests of the Village of Matteson that said territory be annexed to the Village of Matteson; and

WHEREAS, all of the requirements of Chapter 24, Section 7-1-10 and all other necessary legal requirements of the statutes of the State of Illinois have been complied with.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Matteson, Cook County, Illinois, as follows:

Section 1. That the following described territory:

The South 70.00 feet of the Northeast 1/4 lying West of the West line of the East 400.00 feet of the West 1/2 of the East 1/2 of the said Northeast 1/4 of Section 20, Township 35 North, Range 13 East of the Third Principal Meridian; the North 70.00 feet of the Southeast 1/4 lying West of the Southerly extension of the West line of the East 400.00 feet of the West 1/2 of the East 1/2 of the said Northeast 1/4, (except the South 9.00 feet of the East 50.00 feet of the West 169.15 feet of the said North 70.00 feet), of Section 20, Township 35 North, Range 13 East of the Third Principal Meridian; the South 70.00 feet of the Southwest 1/4 and the North 70.00 feet of the Southwest 1/4 of Section 20, Township 35 North, Range 13
