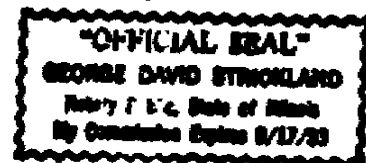

PARCEL ONE: (The property lying East of North Ernst Court)
