WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement (the "Agreement") dated as of December 6, 1989;

WHEREAS, pursuant to the Agreement, Assignor agrees to assign to Assignee that certain Mortgage dated as of January 25, 1988, granted to Assignor by Lake Shore National Bank, as Trustee under Trust Agreement dated November 30, 1984 and known as Trust No. 4967 ("Mortgagor"), to secure, inter alia, the performance and observance by Mortgagor of Mortgagor's obligations under that certain note in the original principal amount of \$4,775,000.00 (the "Note");

WHEREAS, the Mortgage encumbers the real property described and set forth in Exhibit A attached hereto and made a part hereof; and

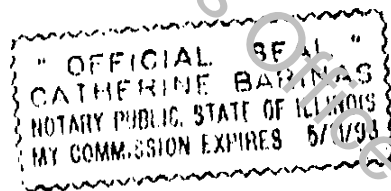
