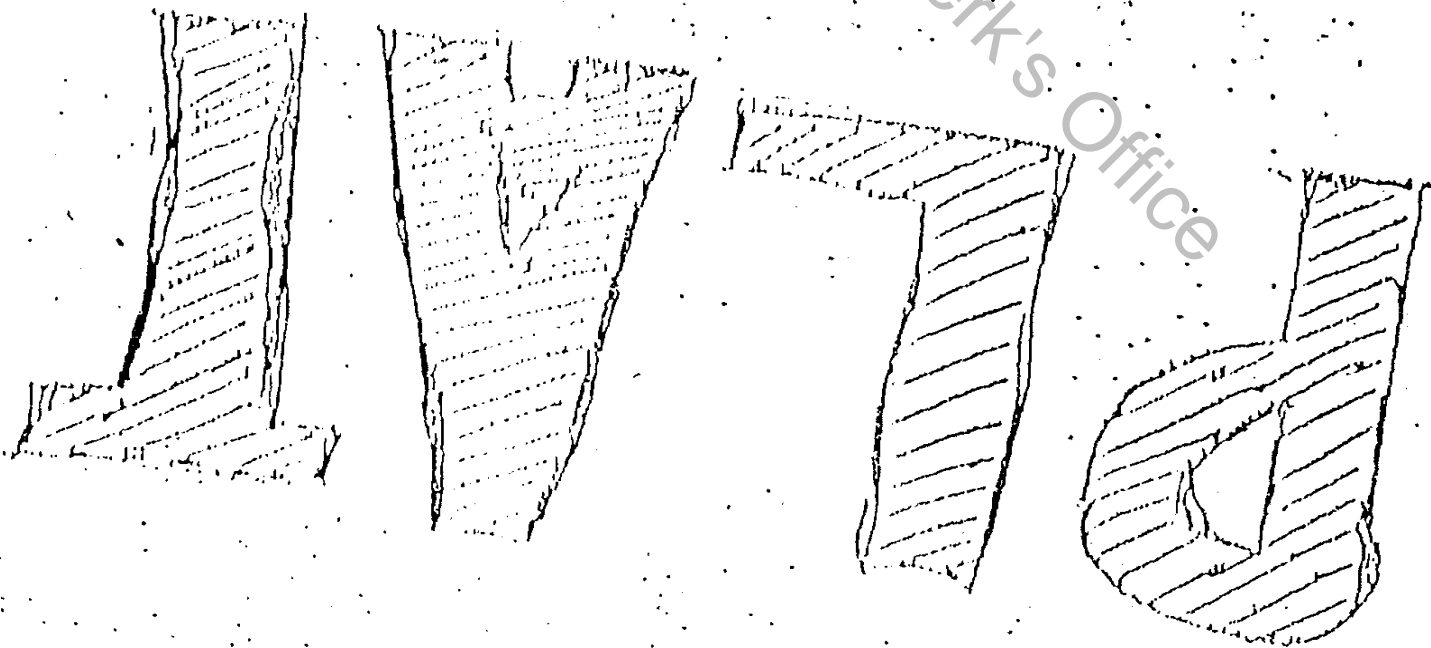

AN ORDINANCE ANNEXING CERTAIN TERRITORY KNOWN AS THE GALLAGHER & HENRY SUBDIVISION TO THE CITY OF PALOS HEIGHTS

WHEREAS, the territory hereinafter described is unincorporated and contains less than 60 acres, and is contiguous to the City of Palos Heights; and

WHEREAS, a petition requesting the annexation of the territory has been presented to the City of Palos Heights signed by all of the owners of record and not less than 51% of the electors residing in the territory; and

WHEREAS, notice has been served in accordance with law upon the appropriate Fire Protection Districts; and

WHEREAS, appropriate notice in accordance with law has been published in a newspaper of general circulation;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PALOS HEIGHTS, as follows:

Section 1. That there is hereby annexed to the City of Palos Heights the territory described as follows:

THE EAST 1/2 OF THE SOUTH 1/2 OF THE SOUTHEAST 1/4 OF SECTION 35, TOWNSHIP 37 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, (EXCEPT THE NORTH 500 FEET OF THE EAST 661.44 FEET THEREOF) IN COOK COUNTY, ILLINOIS, CONTAINING 31 NET ACRES MORE OR LESS.

Permanent Tax Index Number: 23-35-403-005-0000 (Vol. 152)

Section 2. That a true and correct copy of this ordinance together with an accurate map of the annexed territory shall be recorded in the Office of the Recorder of Deeds, Cook County, and a document of annexation shall be filed with the County Clerk and County Election Authority.
