I, the undersigned officer, appointed by the President of the Board of Local Improvements of the City of Hickory Hills, Illinois, to make a special assessment in the cause above entitled, respectfully reports and certifies under oath to said Court that I did take and subscribe an oath that I would in this matter a true and impartial assessment make of the cost of said improvement above mentioned, upon the property benefited by such improvement, to the best of my ability and according to law, and in accordance with the ordinance providing for such improvement, which oath was heretofore filed and made by reference thereto a part of this report and assessment roll; that I assessed the cost of said improvement, amounting to \$99,337.67 upon the property benefited as a special assessment, as provided by said ordinance; and that the amounts assessed against the public and upon each parcel of land so assessed are just and equitable and do not exceed the benefits which will in each case be derived from said improvement, and that no lot, block, tract or parcel of land has been assessed more than its proportionate share of the cost of said improvement, as I verily believe, and that the above and foregoing is a true and correct assessment roll and statement made by me, and contains a list of all the lots, blocks, tracts or parcels of land assessed by me on account of said improvement, with a description of said lots, blocks, tracts or parcels of land, respectively, and also opposite to such description I have designated in appropriate columns the amount assessed against each lot, block, tract or parcel of land, and the amount of each installment, and the name of the person who paid the taxes on each such parcel during the last preceding calendar year in which taxes were paid, ascertained upon investigation by me, and the residence of each person so paying the taxes on each such parcel, so far as the same could on diligent inquiry be found, that I did personally make a careful examination of the Collector's books showing the payment of general taxes during the last preceding year in which the taxes were paid

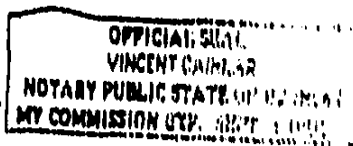
