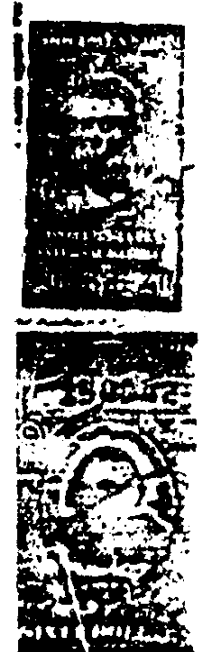

SECTION 31, TOWNSHIP 40 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS, and State of Illinois, to-wit:
All of lot 1 and that part of lots 2, 3 and 4 in Kuno's 1/4 Section Resubdivision of lots 2, 3, 4 and 5 of Armstrong's Subdivision of the North 1/4 acre of Block 53 in Canal Trustee's Subdivision of the North 1/4 and the north 1/2 of the South 1/2 and the East 1/2 of the South West 1/4 of Sec. 33, Township 40 North, Range 14, East of the third principal meridian in Cook County, Illinois described as follows: Beginning at the Southeast corner of said lot 1, thence southeasterly along the southeasterly line of said lot 1 a distance of 51 feet East of and parallel to the West line of said lots 2 and 3; thence East on a line 51 feet East of the parallel with the East line of said lots 2 and 3 to a point on a line 100 feet southeasterly of and parallel with the northeasterly line of said lot 2; thence northeasterly along a line 50 feet southeasterly and parallel with the northeasterly line of said lot 2 to the northeasterly line of said lot 2; thence southeasterly along the southeasterly line of said lot 2 to the West line of lots 2 and 3 and thence along the West line of said lots 2 and 3 to the South line
