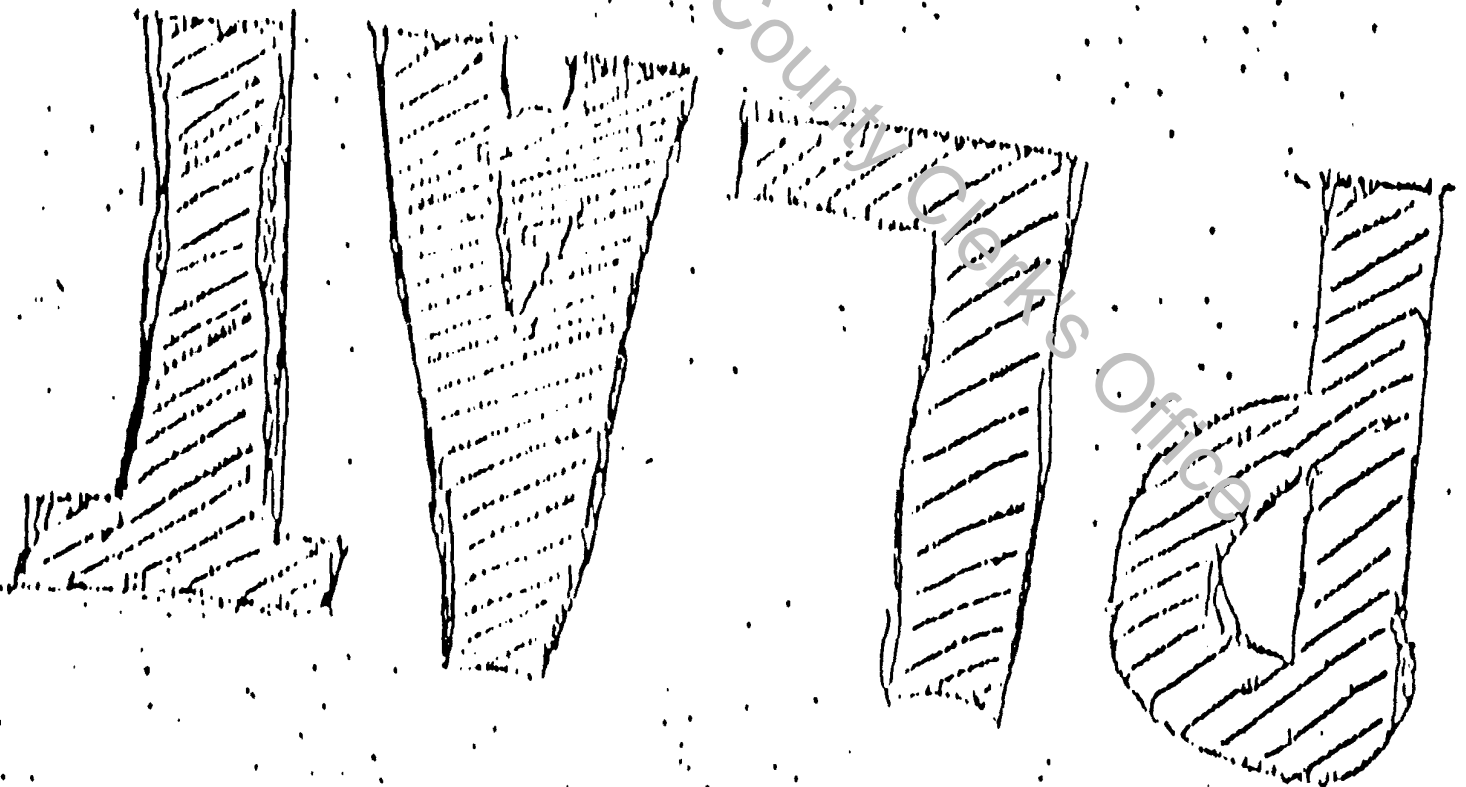

WHEREAS, pursuant to authority granted to Declarant pursuant to that certain Environmental Preservation Declaration for the Courts of Regent Wood, dated July 14, 1987, made by Declarant, which was recorded in the Office of the Cook County, Illinois, Recorder of Deeds on August 25, 1987, as Document No. 87467969, as said instrument was amended by Supplement to Environmental Preservation Declaration for the Courts of Regent Wood executed by Declarant on and dated as of August 16, 1989, and recorded in the Office of the Cook County, Illinois, Recorder of Deeds on August 22, 1989, as Document No. 89389821, and as amended by amendment recorded October 10, 1989, as Document 89478311, Declarant desires to amend the said Subdivision Plat.

NOW, THEREFORE, for and in consideration of the covenants herein contained, Declarant does hereby amend the said Subdivision Plat so as to show and describe Lot 26 thereon as set forth on Exhibit A attached hereto and made a part hereof.

It is expressly understood that this instrument is made by the undersigned, not personally but solely as Trustee for the purpose of binding that part of the Trust Estate specifically described herein, and no personal liability or responsibility is assumed by it nor shall at any time be asserted or enforceable against GLENVIEW STATE BANK or any of the beneficiaries under said Trust Agreement on account of this instrument.

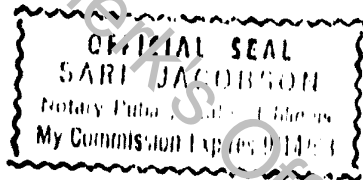
