I, RICHARD E. PATCH, of Chicago, Illinois, being of full age, sound mind and memory and under no restraint, do make, publish and declare this instrument to be my Last Will and Testament and hereby revoke all Wills and Codicils ever before made by me.

I do hereby state that I am married.

ARTICLE I

I direct my Executor to pay all the reasonable expenses of my last illness, of my funeral and burial and of the administration of my estate.

ARTICLE II

I direct my Executor to pay all inheritance, transfer, estate and similar taxe; (including interest and penalties) assessed or payable by reason of my death on any property or interest in property which is included in my estate for the purpose of computing taxes. My Executor shall not require any beneficiary under this Will to reimburse my estate for taxes paid on property passing under the terms of this Will.

ARTICLE III

I hereby authorize my Executor to utilize the services of an attorney, accountant and any other professional as may be necessary in the administration of this, my Last Will and Testament. The expenses incurred by the Executor using such professional services shall be an expense to my estate and shall be paid by my estate.

ARTICLE IV

My Executor named herein shall be entitled to reasonable compensation commensurate with the services actually performed and to reimbursement for expenses properly incurred.

ARTICLE V

I give, devise and bequeath the entire residue of my estate, whether real, personal or mixed, of every kind, nature and description whatsoever, and wherever situated, which I may now own or hereafter acquire, or have the right to dispose of at the time of my death, by the power of appointment or otherwise to my wife, THEONELL PATCH, absolutely and in fee simple.

ARTICLE VI

Should, however, my Wife, THEONELL PATCH predecease me or fail to survive me by thirty (30) days, then the gifts, devises and bequests to THEONELL PATCH shall fail and be of no effect, and I then make the following specific gifts to the following named person(s): the tea ind coffee silver service to RITA L. HARRITY, my daughter; and the coin and silver bar collection along with the collector's books, and all of Lots 3 in Block 458 of Rio Grande Estates, Unit No. 21, according to the map thereof recorded in the office of the Clerk of Valencia County, New Mexico to RICHARD K. ARTICLE VII

should, however, my wife, THEONELL PATCH, redecease me or fail to survive me by thirty (30) days, then the gifts, devises and bequests to THEONELL PATCH shall fail and be of no effect, and in that event, I give, devise and bequeath the entire residue of my estate, whether real, personal or mixed, of every kind, nature and description whatsoever, and wherever situated, which I may now own or hereafter acquire, or have the right to dispose of at the time of my death, by the power of appointment or otherwise, to my children, RITA HARRITY and RICHARD K. PATCH, absolutely and in fee simple, share and share alike.

should any such child predecease me, then his or her share shall pass per stirpes, that is (a) if that child has living issue, the portion of my estate otherwise reserved for that child shall be distributed among said living issue by right of representation; or (b) if that child has no living issue, the portion of my estate otherwise reserved for that child shall be distributed among those of my children who did survive me and, by right of representation, among the living issue of those of my children who did predecease me.

ARTICLE IX

I nominate and appoint RITA L. HARRITY, my daughter as Executor of this, my Last Will and Testament, and require that said Executor serve without bond.

In the event that the above-named Executor shall, for any reason, fail to qualify, or having qualified, fail to complete the administration of my estate, I nominate and appoint RICHARD K. PATCH, my son instead and give to said Executor all rights, powers and immunities set forth in this Will, including the requirement that said Executor serve without bond.

ARTICLE X

Regardless of anything in this instrument to the contrary, no Trust shall continue more than twenty-one (21) years after the death of the survivor of myself, my spouse and each lineal descendant of mine living at the time of my death. Immediately prior to the expiration of such period, each Trust then in existence shall terminate, and the then existing principal of each such Trust, including any undistributed or accrued income thereof, shall vest in and be distributed to its then current income beneficiary.

ARTICLE XI

In addition to the powers and authority conferred upon executors and trustees by law, my Executor and Trustee, if any, or any duly appointed successor shall have authority without adjudication, order or direction of the court:

- (a) To sell, pursuant to option or otherwise, at public or private sale and upon such terms as the Executor shall deem best, any real or personal property belonging to my estate, without regard to the necessity of such sale for the purpose of paying debts, taxes or legacies;
- (b) To retain any or all of such property not so required without liability for any depreciation thereof;
- (c) To assign or transfer certificates of stock, bonds or other securities;
- (d) To adjust, compromise and settle any and all claims in favor of or against my estate;
- (e) To conduct and carry on all business now conducted by me and to do all things necessary or proper in the usual course of business until such time as the business can be sold or distributed as a going concern or otherwise, and the Executor shall be exonerated from any loss which may result thereby; and
- (f) To do any and all things necessary or proper to complete the administration of my estate, all as fully as I could do if living.

ARTICLE XII

The omission in this, my Last Will and Testament, of any provision for any other relative or porson is not due to oversight or neglect, but is based upon my considered desire to benefit only the beneficiaries designated herein. Notwithstanding any and all of the other provisions of this, my Last Will and Testament, if any beneficiary shall object to the probate of this Will or in any manner, directly or indirectly, contest or aid in the contesting of this Will, any provisions hereof or any part of the estate hereunder, then he or she shall be deemed to have predeceased me for the purposes of this Will and any provisions herein contained.
