Excerpts From Internal Revenue Code
Sec. 6321. Lien For Taxes

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition thereto) shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the lien imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors.—The lien imposed by section 6321 shall not be valid as against any purchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor who acquires his lien or interest in the property in good faith and without notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

(b) Place For Filing Notice; Form.—

- (1) Place For Filing - The notice referred to in subsection (a) shall be filed -
 - (A) Under State Law
 - (i) Real Property - In the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated; and
 - (ii) Personal Property - In the case of personal property, whether tangible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated; or
 - (iii) With Clerk Of District Court-In the office of the Clerk of the United States district court for the judicial district in which the property subject to lien is situated; whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or
 - (iv) With Recorder Of Deeds Of The District Of Columbia-In the office of the Recorder of Deeds of the District of Columbia, if the property subject to the lien is situated in the District of Columbia.

- (2) Office Of Property Subject To Lien - For purposes of paragraphs (1) and (4), property shall be deemed to be situated -
 - (A) Real Property - In the case of real property, at its physical location; or
 - (B) Personal Property - In the case of personal property, whether tangible or intangible, at the residence of the taxpayer at the time the notice of lien is filed.
- (3) Residence - For purposes of paragraph (2)(B), the residence of a corporation or partnership shall be deemed to be the place at which the principal office of such corporation or partnership is located and the principal office of a partnership shall be deemed to be the principal office of a partner whose residence is without the United States and who is not in the District of Columbia.
- (4) Form - The form and content of the notice referred to in subsection (a) shall be prescribed by the Secretary. Such notice shall be valid notwithstanding any other provision of law regarding the form or content of a notice of lien.

Note: See section 6323(d) for protection for certain interests even though notice of lien imposed by section 6321 is filed with respect to:

1. Securities
2. Motor vehicles
3. Personal property purchased in good faith
4. Personal property purchased in casual sale
5. Personal property subjected to possessory lien
6. Real property subjected to mechanic's lien
7. Residential property subjected to mechanic's lien for certain repairs and improvements
8. Airway's liens
9. Certain insurance contracts
10. Feedback loans

(c) Filing Of Notice. - For purposes of this section

- (1) General Rule.—Unless notice of lien is relied in the manner prescribed in paragraph (2) during the required retelling period, such notice of lien shall be treated as filed on the date on which it is filed in accordance with subsection (b) after the expiration of such retelling period.
- (2) Place For Filing.—A notice of lien relied during the required retelling period shall be effective only -
 - (A) If such notice of lien is relied in the office in which the prior notice of lien was filed; and
 - (B) In the case of real property, the fact of retelling is entered and recorded in an entry in the record required by subsection (b) (4), and
 - (C) In any case in which, 30 days or more prior to the date of a retelling of notice of lien under subparagraph (A), the

Secretary received written information (in the manner prescribed in regulations issued by the Secretary) concerning a change in the taxpayer's residence, if a notice of such lien is also filed in accordance with subsection (f) in the State in which such residence is located.

(3) Required Retelling Period.—In the case of any notice of lien, the term "required retelling period" means -
 (A) the one-year period ending 30 days after the expiration of 6 years after the date of the assessment of the tax, and
 (B) the one-year period ending with the expiration of 6 years after the close of the preceding required retelling period for such notice of lien.

Sec. 6325. Release Of Lien Or Discharge Of Property.

- (a) Release Of Lien. — Subject to such regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lien imposed with respect to any internal revenue tax not later than 30 days after the day on which -
 - (1) Liability Satisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become legally unenforceable; or
 - (2) Bond Accepted - There is furnished to the Secretary and accepted by him a bond that is conditioned upon the payment of the amount assessed, together with all interest in respect thereof, within the time prescribed by law (including any extension of such time), and that is in accordance with such requirements, terms, conditions, and form of the bond and sureties thereon, as may be specified by such regulations.

Sec. 6103. Confidentiality and Disclosure of Returns and Return Information.

- (a) Disclosure of Certain Returns and Return Information For Tax Administration Purposes.—
 - (2) Disclosure of amount of outstanding lien.—If a notice of lien has been filed pursuant to section 6321(f), the amount of the outstanding obligation secured by such lien may be disclosed to any person who furnishes satisfactory written evidence that he has a right in the property subject to such lien or intends to obtain a right in such property.
