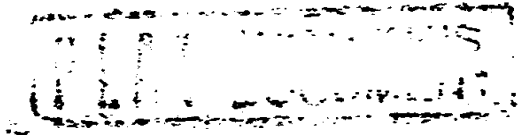

ORDINANCE NO. 90-O-017

AN ORDINANCE ANNEXING PROPERTY
(RICHARD AND RITA SCHULTZ)

BE IT ORDAINED by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

Section 1: That this President and Board of Trustees find as follows:

- (a) A Petition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Tinley Park, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Tinley Park, Cook and Will Counties, Illinois;
- (b) The aforesaid Petition is in proper form under oath, signed by all owners of record of all the land within the territory, there being no electors residing within or on said territory;
- (c) That there is no highway adjacent to or located within the aforesaid territory which is under the jurisdiction of any Township or its Commissioner of Highways, and therefore no notice of the proposed annexation has been served upon and given to any Commissioner of Highways or Board of Town Auditors;
- (d) That the territory is not located within any public library district or fire protection district and therefore no notice has been given to any library district or fire protection district;
- (e) Such territory described in Section 2 is solely within Cook County and not within the corporate limits of any municipality, but is contiguous to the Village of Tinley Park, Cook and Will Counties, Illinois, a municipality existing under the laws of the State of Illinois.

Section 2: That the territory to be annexed to the Village of Tinley Park, Cook and Will Counties, Illinois is described as follows:

The North 240 feet of the East 90.00 feet of the West 445.00 feet; also the North 120.00 feet of the East 20.00 feet of the West 355.00 feet, all in the East 1/2 of the East 1/2 of the Northeast 1/4 of Section 34, Township 36 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.

Lots 1 and 2 in Schuldt Homelands, being a Subdivision of the East 1/2 of the East 1/2 of the Northeast 1/4 of Section 34, Township 36 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.

The South 242.00 feet of the North 275.00 feet of the West 185.00 feet and the South 35.00 feet of the North 275.00 feet of the West 445.00 feet, all in the East 1/2 of the East 1/2 of the Northeast 1/4 of Section 34, Township 36 North, Range 12, East of the Third Principal Meridian in Cook County, Illinois.

Section 3: That the Village Clerk is hereby and herewith instructed to record with the Recorder of Deeds of Cook County, Illinois, and to file with the County Clerk of Cook County, Illinois:

Section 4: That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
