ORDINANCE NO. _90-0-017

AN ORDINANCE ANNEXING PROPERTY (RICHARD AND RITA SCHULDT)

BE IT ORDAINED by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

<u>Section 1</u>: That this President and Board of Trustees find as follows:

- (a) A Petition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Tinley Park, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Tinley Park, Cook and Will Counties, Illinois;
- (b) The aforesaid Petition is in proper form under oath, signed by all owners of record of all the land within the territory there being no electors residing within or on said territory;
- (c) That there is no highway adjacent to or located within the aforesaid territory which is under the jurisdiction of any Township or its Commissioner of Highways, and therefore no notice of the proposed annexation has been served upon and given to any Commissioner of Highways or Board of Town Auditors;
- (d) That the territory is not located within any public library district or five protection district and therefore no notice has been given to any library district or fire protection district;
