## AN ORDINANCE ANNEXING PROPERTY (MELVIN AND DOLORES SCHULDT)

BE IT ORDAINED by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

<u>Section 1</u>: That this President and Board of Trustees find as follows:

- (4) A Petition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Tinley Park, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Tinley Park, Cook and Will Courties, Illinois;
- (b) The alor; said Petition is in proper form under oath, signed by all owners of record of all the land within the territory there being no electors residing within or on said territory;
