ORDINANCE NO. 90-0-019

AN ORDINANCE ANNEXING PROPERTY
(MELVIN AND DOLORES SCHULDT)

BE IT ORDAINED by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

Section 1: That this President and Board of Trustees find as follows:

- (a) A Petition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Tinley Park, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Tinley Park, Cook and Will Counties, Illinois;
- (b) The aforesaid Petition is in proper form under oath, signed by all owners of record of all the land within the territory there being no electors residing within or on said territory;
- (c) That there is no highway adjacent to or located within the aforesaid territory which is under the jurisdiction of any Township or its Commissioner of Highways, and therefore no notice of the proposed annexation has been served upon and given to any Commissioner of Highways or Board of Town Auditors;
- (d) That the territory is not located within any public library district or fire protection district and therefore no notice has been given to any library district or fire protection district;
- (e) Such territory described in Section 2 is solely within Cook County and not within the corporate limits of any municipality, but is contiguous to the Village of Tinley Park, Cook and Will Counties, Illinois, a municipality existing under the laws of the State of Illinois.

Section 2: That the territory to be annexed to the Village of Tinley Park, Cook and Will Counties, Illinois is described as follows:

Beginning at a point in the North line of the said West 1/2 of the Northwest 1/4 of Section 35, Township 36 North, Range 12 East of the Third Principal Meridian, that is 454.74 feet East of the Northwest corner thereof and running thence South along a line that forms an angle of 90° 0' 0" with the said North line of the West 1/2 of the Northwest 1/4 a distance of 225.0 feet to a point; thence East along a line forming an angle of 90° 0' 0" to the left of a prolongation of the last described course, a distance of 193.60 feet to a point; thence North along a line forming an angle of 90° 0' 0" to the left of a prolongation of the last described course, a distance of 225.0 feet to a point in the

North line of said West 1/2 of the Northwest 1/4 of Section 35; thence West along the said North line of the West 1/2 of the Northwest 1/4 of Section 35, a distance of 193.60 feet to the place of beginning, all in Cook County, Illinois.

Section 3: That the Village Clerk is hereby and herewith instructed to record with the Recorder of Deeds of Cook County, Illinois, and to file with the County Clerk of Cook County, Illinois:

- (a) a copy of this Ordinance certified as correct by the Clerk of said Village of Tinley Park; and
- (b) a plat of the land included in this annexation, as required by law, said plat to be attached to the aforesaid certified copy of this Ordinance.

Section 4: That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
