
### SATISFACTION RELEASE OF JUDGMENT



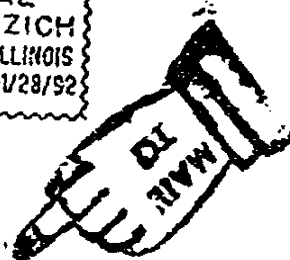
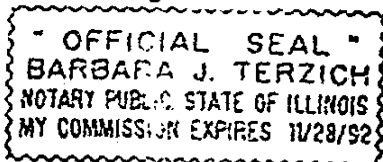
