PARTIAL RELEASE OF MORTGAGE

WHEREAS, Royal St. James Ltd., a corporation originated under the laws of Illinois, F. o. No. 1987, Palos Park, Illinois 60464 ("Mortgagor"), by a mortgage dated May 29, 1987 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on June 3, 1987 as document number 870607287 granted and conveyed unto Peoples Developers and Lenders Corporation, F.A. (previously Peoples Bank for Capitalization Corporation) and its successors, the premises therein particularly described ("the mortgaged property"), to secure the payment of the sum of Three Million Five Hundred Thousand and 00/100 Dollars (\$3,500,000.00), with interest at eight percent per annum;

WHEREAS, Mortgagor has requested Lender to release the premises hereinabove described, being part of said Mortgaged Premises, from the Lender's operation of said Mortgage.

Now, WHEREAS, in consideration of the payment of ten and 00/100 dollars (\$10.00) to the Lender by Mortgagor at the time of execution hereto, the recipient whereof hereby acknowledged, plus other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, to the same, resurce, release, quit claim and discharge from the Lender and payee of said Mortgage and Assignment of Rents and Leases unto Mortgagor and to the heirs and assigns of Mortgagor all that property, parcels or tract of land being a part of the Mortgaged Premises commonly known as 11614 Autobahn Drive, East, Palos Park, Illinois and briefly described as follows:

THE EIGHTH PARCEL OF THE 60TH SUBDIVISION IN THE FARM UNIT 2, BEING A SUBDIVISION OF FARM 31 THE 60TH 1/2 OF THE SOUTHEAST 1/4 OF SECTION 23, TOWNSHIP 31 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

PARCEL 2: EXCERPTS FOR PURPOSE AND ADDRESS FOR THE BENEFIT OF PARCEL 1 AS SET OUT IN THE DEED IN PLAT OF SUBDIVISION RECORDED AS DOCUMENT NUMBER 872530-561.

To have and to hold the same, with the appurtenances, unto Mortgagor and to the assigns of Mortgagor, forever, freed and discharged of and from all and sundry mortgages, leases, rents, joint thereof; paid, due, always nevertheless, that nothing herein contained shall in any wise impair, alter or diminish the effect of item or itemization of the aforesaid Mortgage on the remaining part of the Mortgaged Premises, not thereby released therefrom, or limit the rights and remedies of the holder hereof, and that said Mortgagor shall remain in full force and effect for the balance of the Mortgaged Premises so named, released.




