THIS AGREEMENT dated March 9, 1990, by and between the Harris Bank Hinsdale, National Association ("Mortgagee"); the Harris Bank Hinsdale, National Association as Trustee under Trust Agreement dated March 8, 1988, and known as Trust No. L-1856 ("Mortgagor") witnesseth:

WHEREAS, Mortgagee has agreed to lend Mortgagor the principal amount of Two Million Five Hundred and No/100 dollars (\$2,500,000.00) evidenced by a promissory note dated March 9, 1988, and secured by a Mortgage dated March 9, 1988, recorded March 23, 1988, in the recorder's office of Cook County, Illinois as Document No. 08118686, mortgaging, granting, and conveying to Mortgagee the property legally described as:

WHEREAS, said note is due and payable and the parties wish to amend the terms of the mortgage and note;

WHEREAS, on March 9, 1989, the parties hereto executed a Loan Modification Agreement extending the maturity date and amending the terms of the Mortgage, Note and Assignment of Accounts Receivable and Equipment recorded April 7, 1989 in the Recorder's Office of Cook County as Document No. 89152892.

WHEREAS, on August 14, 1989, the parties hereto executed a Loan Modification Agreement extending the maturity date, and increasing the loan amount to \$3,500,000.00, amending the terms of the Mortgage, Note and Assignment of Accounts Receivable and Equipment recorded September 1, 1989, in the Recorder's Office of Cook County as Document No. 89411751.

NOW THEREFORE, the parties hereto agree to extend the maturity date of the Mortgage, Note and Assignment of Accounts Receivable and Equipment to March 9, 1991.

In all other respects, the parties hereto reconfirm and ratify the provisions of the mortgage and note.

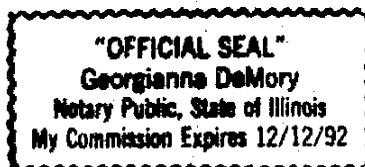

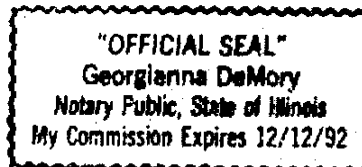
