- 1. The real estate described as Addition XII in Exhibit A attached hereto is hereby annexed and made subject to che Declaration and included within the covenants and restrictions of the Declaration, and shall be deemed to be governed in all respects by the terms and provisions of the Declaration.
- 2. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
