This agreement made and entered into this 30 day of March, 1957, by and between HENRY COUNTY BANK OF GREEN ROCK, ILLINOIS, a corporation organized under the Banking Laws of the State of Illinois, with its principal place of business in the City of Green Rock, in the County of Henry, and State of Illinois; party of the first part, and Robert E & Carol L. Bryant parties of the second part.

WITNESSETH, that Robert E & Carol L. Bryant the part ies of the second part, did on the " day of March, 1957, execute and deliver to said party of the first part, HENRY COUNTY BANK OF GREEN ROCK, a certain mortgage and the note secured thereby, bearing date of said day; which said mortgage was on the " day of March, 1957, recorded in Record Book of Mortgages, on Page , as Document No. 17124731, in the Offices of the Recorder of Deeds, of the County of Cook and State of Illinois.

AND, WHEREAS, there is now due and unpaid upon said loan, the sum of Seventy Seven Thousand Five Hundred Twenty Two -- 54 1/2 Dollars (\$77,520.50) on principal and interest from March 6, 1957.

AND, WHEREAS, the said party of the second part desires that the time of payment of said note be extended as follows: 36 monthly payments of principal & interest in the amount of \$2,077.50 commencing April 1st, 1957. 1 Final payment in the amount of \$73,442.76 due March 1960.

AND, WHEREAS, the party of the first part has required that the interest rate on said promissory note be (increased) (decreased) from 4.5 per annum to 11.5 per annum.

NOW, THEREFORE, it is agreed by and between the parties hereto, that the date of payment of said note shall be so extended and in consideration of said extension the interest rate on the said note shall be increased to 11.5 per annum commencing March 1st; all the other conditions of said note and mortgage, however, shall remain unchanged.




