4. Hazard Insurance. Unless Mortgagee and Mortgagor otherwise agree in writing, incurance proceeds shall be applied to restoration or repair of the Property rhamaged, provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is not economically feasible or if the security of this Mortgage would be impaired, the insurance process shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to borrower. - 8. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in fieu of condemnation, are hereby assigned and shall be paid to Mortgagee.

Mortgagee shall not be recovered to commence proceedings against such successor or refuse to extend time for payment or otherwise modify by reason of any demand made by the original borrower and Mortgagor's successors in interest.
