KNOW ALL MEN BY THESE PRESENTS, that Harris Trust and Savings Bank, an Illinois banking corporation, in consideration of one dollar, and other good and valuable considerations, the receipt whereof is hereby acknowledged, does hereby release, all the right, title, interest, claim or demand whatsoever it may have acquired in, through or by that certain Mortgage and Security Agreement with Assignment of Rents dated July 20, 1989 and recorded July 21, 1989 as Document No. 89-333808 in the premises therein described, situated in the County of Cook, State of Illinois, as follows, to-wit:

Unit 66-1 in Cobbler's Crossing Unit 4 being a subdivision in the South 1/2 of Section 7, Township 41 North, Range 9 East of the Third Principal Meridian, according to the plat thereof recorded July 19, 1989 as document no 89-322814 in Cook County, Illinois.

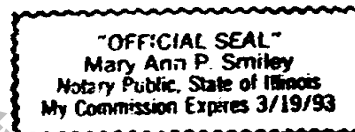
