Assignor agrees that this Assignment shall cover all future leases, whether written or verbal, or any letting of, or any agreement for the voc or occupancy of any time of said premises.
Assignor further agree, that it will not assign the rent or any part of the rent of said premises, or cancel or amend any lease now in existence or hereafter made, or coffer rints thereunder for a period further in advance then thirty (30) days without the written consent of the Assignee, or do any other act whereby the kip of the aforesaid mortgage may, in the opinion of the Assignee, be impaired in value or quality.
Assignor further agrees that this assignment shall remain in full force and effect so long as the principal note remains unpoid and that this Assignment may be enforced by the Assignment shall remain and assignment of said note.

(a) To collect all of the rents, issues and profits for due or which may hereafter become due, or by virtue of any lease, whether written or verbal, or any letting of, or agreemen, for the use or occupancy of any part of said premises and to take such action, legal or equitable, as may be deemed necessary to er force payment of such rents, issues and profits;
(b) To use and possess furniture, furnishings, equipment, (am)s, signs, books, records and files, and all other personal property used in the operation of Assignor's business;
legal or equitable, as may be deemed necessary to er force payment of such rents, issues and profits; (b) To use and possess furniture, furnishings, equipment, ram's, signs, books, records and files, and all other personal property used in the operation of Assignor's business; (c) To operate the property and business of Assignor and pay all visit of operations, including costs not met from income collections obtained from such operations, and to make such other disbursements as any be reasonably necessary, in the opinion of the Assignce, to properly operate said property, and any and all such sums of movies ad sinced for such purposes, or any of them, shall be deemed as additional principal sums secured by the mortgage or trust deed show described. Nothing herein contained, however, shall be construed as requiring Assignce to advance or expend money for any of the proposes aforesaid;

 To the payment of taxes and assessments levied and assessed against the property described herein as aid taxes and assessments become due and payable;
3. To the payment of premiums due and payable on policies insuring said premises;
4. To the payment of installments of principal and interest on the principal note as they become due and payable and to the payment of any other amounts which may become due and payable pursuant to the terms of said mortgage or trust deed; and
