5. Preservation and Maintenance of the Property, Leaseholds.

(c) No Walver.

Any Borrower who co-signs this Security instrument but does not execute the Note: (a) is co-signing this Security, instrument only to mortgage, grant and convey that Borrower's interest in the Property under the terms of this Security Instrument; (b) is rist personally obligated to pay the sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower may agree to extend, modify, forbear or make any accommodations with regard to the term of this Security Instrument or the Note without that Borrower's constant.

Any notice to Borrower provided for in this Security Instrument shall be given by delivering it or by malling it by first class mail unless applicable law requires use of another method. Any notice provided for in this Security Instrument shall be calemed to have been given to Borrower. or Lender when given as provided in this paragraph.

14. Governing Law; Severability.

This Security Instrument shall be governed by Federal law and the law of the jurisdiction in which the Property is in content that any provision or clause of this Security Instrument or the Note conflicts with applicable law, such conflict shall not rifect other provisions of this Security Instrument and the Note are declared to be severable.

15. Borrower's Copy.

Borrower shall be given one conformed copy of this Security instrument.

16, Assignment of Rents.

Borrower unconditionally assigns and transfers to Lender all the rents and revenues of the Property. Borrower authorizes Lender or Lender's agents to collect the rents and revenues and hereby directs each tenant of the Property to pay the rents to Lender's agents.

- 19. Walver of Homestead. Borrower waives all right of homestead exemption in the Property.

Borrower agrees that should this Security instrument and the note secured thereby not be eligible for insurance under the National Housing Act within NINETY DAYS from the date hereof, Lender may, at its option and notwithstanding anything in Paragraph 9, require immediate payment in full of all sums secured by this Security instrument. A written statement of any authorized agent of the Secretary dated subsequent to NINETY DAYS from the date hereof, declining to insure this Security instrument and the note secured thereby, shall be deemed conclusive proof of such ineligibility. Nothwithstanding the foregoing, this option may not be exercised by Lender when the unavailability of insurance is solely due to Lender's failure to remit a mortgage insurance premium to the Secretary.
