THIS MORTGAGE ("Mortgage") is made this between Mortgagor, Susan J. Melly Single, Never Married (herein "you," "your" or "yours") and the Mortgagee, Citibank, Federal Savings Bank, a corporation organized and existing under the laws of the United States, whose address is One South Dearborn Street, Chicago, Illinois 60603 (herein "we," "us" or "our").

WHEREAS, Susan J. - 4. Finance Charges. You agree to pay interest (a "Finance Charge") on the Duestanding Principal Balance of your Preferred Line Account as determined by the Agreement. You agree to pay interest at the Annual Percentage Rate of 14.4000 %.
- 5. Application of Payments. Unless applicable law provides otherwise, all payment; received by us under the Agreement and this Mortgage shall be applied as provided in the Agreement. Charges incurred pursuant to paragraph 7 hereof will be treated as Finance Charges for purposes of application of payments only.

6. Charges; Liens. You shall pay all taxes, assessments, charges, fines and impositions attribitable to the Property which may attain priority over this Mortgage, and leasehold payments or grounds rents, if any. You shall comptly furnish to us

receipts evidencing these payments.

7. Protection of Our Rights in the Property; Mortgage Insurance. If you fail to perform the covenants and agreements contained in this Mortgage, or there is a legal proceeding that may significantly affect our rights in the property (such as a proceeding in bankruptcy, probate, for condemnation or to enforce laws or Regulations), then we may do and pay for whatever is necessary to protect the value of the Property and our rights in the Property. 10. Prior Mortgages. your home, the Property, is transferred as more fully described in paragraph 12 below; or (5) any of you die.

(b) If you are in default under the Agreement or this Mortgage, we may terminate your Preferred Line Account and require you to pay immediately the principal balance outstanding, any and all interest you may owe on that amount, together with all other fees, costs or premiums charged to your account. The principal balance outstanding under the Agreement after default shall continue to accrue interest until paid at the rate provided for in the Agreement as if no default had occurred. In addition to the right to terminate your Preferred Line Account and declare all sums immediately due and owing under the Agreement, in the earnt of a default, we shall have the right to refuse to make additional Loans to you under the Agreement (reduce your Credit Lanit). If we refuse to make additional Loans to you after default, but do not terminate your account, you must notify us in writing if you would like to obtain further Loans and can demonstrate that the condition that led to the default no longer exists.

12. Transfer of the Property. If all or any part of the Property, or an interest therein is sold or transferred by you, or if the beneficial interest, or any part thereof, in any land trust holding title to the Property is assigned, sold or transferred, or if you or the title holding trust enter into Articles of Agreement for Deed or any agreement for installment sale of the Property or the beneficial interest in the dive holding land trust, without our prior written consent, excluding: (a) the creation of a purchase money security interest 5.1 household appliances; (b) a transfer by devise, descent or by operation of law upon the death of a joint tenant; or (c) the grant or any leasehold interest of three (3) years or less not containing an option to purchase,

Right to Reduce Line of Credit No may reduce your Credit Limit or suspend your credit privileges (refuse to make additional Loans) if: (a) the value of the your Property drops significantly below the appraised value upon which the Agreement was based; (b) a material change in your financial circumstances gives us reason to believe that you will not be able to make the required payments; (c) governmental ation precludes us from charging the Annual Percentage Rate permitted by the Agreement or governmental action adversely af ects our lien priority such that the value of out security interest falls below 120% of your Credit Limit; (d) we are notified by our forgulatory Agency that continuing to make Loans constitutes an unsafe and unsound practice; or (e) you are in default of any material obligation under the Agreement. If we refuse to make further Loans to you, but do not terminate your Preferred Line Account, you must notify us in writing if you would like to obtain further Loans and can demonstrate that the conditions that gave us the right to refuse to make further Loans has changed.

14. Acceleration; Remedies. Upon a Default by you linger this Mortgage, we, at our option, may require immediate payment in full of all sums secured by this Mortgage without urther demand and may foreclose this Mortgage by judicial proceeding. We shall be entitled to collect all expenses incurred in) ursuing the remedies provided in this paragraph 14, including, but not limited to, reasonable attorneys' fees and costs of title vidence.
