ABROGATION OF EASEMENT

THIS ABROGATION OF EASEMENT is made as of the 10 day of May, 1990 by LaSalle National Bank, a national banking association, not personally, but solely as Trustee under Trust Agreement dated January 1, 1989 and known as Trust Number 114065 ("Trust 114065").

WITNESSETH:

WHEREAS, by Deed recorded December 27, 1979 as document 25295300, Consolidated Rail Corporation, a corporation of the Commonwealth of Pennsylvania ("Conrail") reserved, unto itself, its agents, independent service contractors, successors, licensees and permittees; an easement (the "Easement") for railroad purposes over a portion of the land described in Exhibit "A" attached hereto;

WHEREAS, by that certain Assignment of Easement recorded with the Cook County Recorder of Deeds on 5-11-90 as document 90219032, Conrail assigned its interest in and to the Easement to LaSalle National Bank, N.A. not personally, but solely as Trustee under Trust Agreement dated January 1, 1989 and known as Trust Number 114065;

WHEREAS, by deed from LaSalle National Bank, a national banking association, not personally, but solely as Trustee under Trust Agreement dated July 1, 1979 and known as Trust Number 100819, recorded with the Cook County Recorder of Deeds on 4-17-90, 1990, as document 90173167, Trust 114065 succeeded as the present owner of the land described in Exhibit "A", and

WHEREAS, Trust 114065 now wishes to terminate and abrogate the Easement; and to place of record evidence of its intention to so do;

NOW THEREFORE, Trustee hereby states as follows:

1. The aforesaid recitals are hereby incorporated and made a part of this Abrogation of Easement.
2. The aforesaid Easement is hereby absolutely and irrevocably abrogated and terminated.

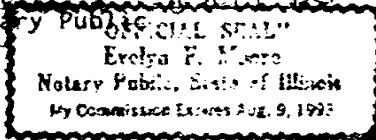
