## <u>EXHIBIT "A"</u>

Upon termination or dissolution of the partnership, the partners shall proceed to wind up the partnership and liquidate and distribute the partnership assets as follows:

Payruent or provision for payment shall be made for all the debts and liabilities of the partnership and all expenses of liquidation, including the establishment of such cash of the partnership;
