AGREED ORDER

This cause coming on to be heard pursuant to the petition of Suzanne Gunn k/v/a Suzanne Truax, for reimbursement of attorney's fees, and upon the petition of the attorney for the minor children, Marcia Gevers, for attorney's fees, responses having been filed thereto, and the parties having entered into a settlement negotiation, and having reached full agreement, by agreement, it is hereby ordered as follows:

1. Within 21 days after entry of this order, David Gunn shall pay to Suzanne Truax, the sum of \$4,800.00 as and for full reimbursement of attorney's fees incurred in the above-captioned cause. Any additional attorney's fees owed to the attorneys for Suzanne Truax, shall be paid solely by Suzanne Truax.
2. David Gunn is hereby ordered to pay \$1900.00 outstanding attorney's fees owed to the attorney for the minor children, Marcia Gevers, without contribution from Suzanne Truax.
3. Beginning with the taxable year 1990, and for each and every year thereafter, Suzanne Truax and David Gunn shall alternate claiming the deduction for the dependency exemption for their children pursuant to Section 152(c) of the Internal Revenue Code. The parties agree that they will sign Internal Revenue Service Form 8332, or any other necessary documents to implement the terms of this order. The parties agree to provide signed documents to one another prior to April 15, of each year. Suzanne Truax shall be entitled to take the dependency exemption in even numbered years, and David Gunn shall take the dependency exemption in odd numbered years, provided, however, that he has made all child support payments required for that year. The parties further agree that they will not claim the children as dependency exemptions during the year that the other party is entitled to exemption.
