CLAIM FOR LIEN

The Village of Park Forest, Cook and Will Counties, Illinois, a municipal corporation (the "Village"), hereby files its Claim for a Lien in the amount of \$1,070.00 against the following described real estate to-wit:

commonly known as 21st Berry, and identified for real estate tax purposes as P.I.N. 44-24-437-013, said lien being in the amount of the actual cost and expense incurred by rehabilitation improvements located on the above-described real estate in accordance with Owner Acceptance of Repair Specifications executed by Patricia Stevenson, owner of record of said real estate (the "Owner"), and dated 7/11/80; and pursuant to the Owner Participation Agreement dated 2/20/90, by and between the Village and the Owner, by which the Owner agrees to the filing of this lien.

In the event Owner conveys, transfers, grants, assigns, warrants, sells or quit claims the real estate hereinabove described, within five (5) years from the date hereof, said Owner shall immediately repay to the Village one of the following amounts:

1. if, within one (1) year from the date hereof, 100% of the amount above stated with no interest;
2. if, within two (2) years from the date hereof, 80% of the amount stated with no interest;
3. if, within three (3) years from the date hereof, 60% of the amount stated with no interest;
4. if within four (4) years from the date hereof, 40% of the amount stated with no interest; or
5. if within five (5) years from the date hereof, 20% of the amount stated with no interest.

In the event Owner does NOT convey, transfer, grant, assign, warrant or sell said real estate hereinabove described within five (5) years from the date hereof, this lien shall automatically terminate and all obligations of Owner hereunder discharged forever.
