AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF ROLLING MEADOWS, ILLINOIS (Suff)

WHEREAS, a written petition, under oath, signed by all the owners of record of the land hereinafter described, has been filed with the City Clerk of the City of Rolling Meadows, requesting that said territory be annexed to the City of Rolling Meadows; and

WHEREAS, there are no electors residing on the territory; and

WHEREAS, the said territory is not within the corporate boundaries of any municipality but is contiguous to the City of Rolling Meadows; and

WHEREAS, notice upon the trustees of the Palatine Township Rural Fire Protection District and Palatine Library District have been served, as required, by the Illinois Revised Statutes; and

WHEREAS, the Palatine Township Commissioner of Highways and the Palatine Township Board of Trustees have been notified, in writing, of the proposed annexation of township highways, as required by the Illinois Revised Statutes; and

WHEREAS, the City Council is of the opinion that the annexation of said territory is in the best interest of the City.

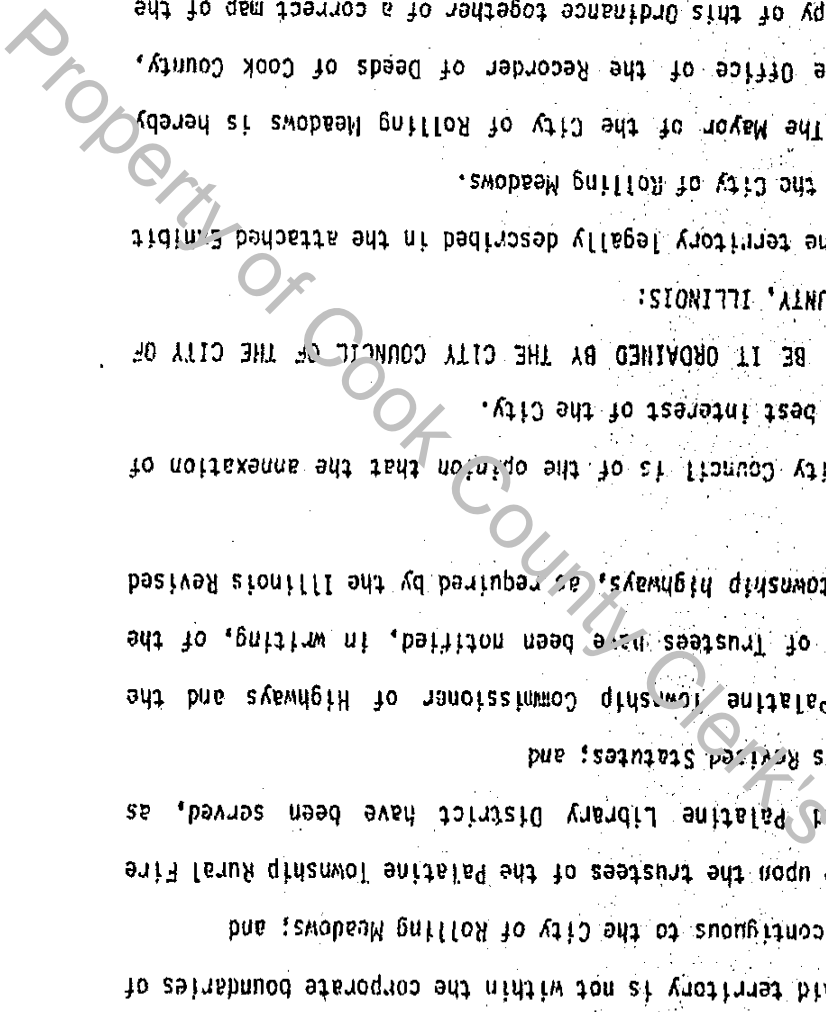

SECTION ONE: The territory legally described in the attached Exhibit "A" is hereby annexed to the City of Rolling Meadows.

SECTION TWO: The Mayor of the City of Rolling Meadows is hereby directed to file in the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy of this Ordinance together of a correct map of the territory annexed.

SECTION THREE: The City Attorney is hereby directed to file in the Office of the Recorder of Deeds of Cook County, Illinois, an affidavit that notice has been sent to all of the parties requiring notice of said annexation by the Illinois Revised Statutes.
