AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS (INDIAN CREEK RESIDENTIAL DEVELOPMENT - 15 ACRES).

WHEREAS a written petition, signed by the legal owners of record of all land within the territory hereinafter described, has been filed with the Village Clerk of the Village of Willow Springs, Cook County, Illinois, in the manner required by State statute requesting that said territory be annexed to the Village of Willow Springs; and

WHEREAS, there are no electors residing within the territory; and

WHEREAS, the territory is not within the corporate limits of any municipality but is contiguous to the Village of Willow Springs; and

WHEREAS, legal notices regarding the intention of the Village to annox the territory have been sent to all public bodies required to receive such notice by State Statute; and

WHEREAS, copies of such notices together with an Affidavit of Service shall be recorded in the Circo of the Recorder of Deeds of Cook County, Illinois; and

WHEREAS, the successor in title to the logal cyrors of said record of territory and the Village of Willow Springs have entered into a valid and binding annexation agreement dated as of June 4, 1990 (Annexation Agreement for Indian Creek Residential Development), relating to the territory; and

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the terms of said annexation agreement and with the statutes of the State of Illinois; and

WHEREAS, the President and Board of Trustees have determined that it is in the best interest of the Village of Willow Springs that the territory be annexed to the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. Annexation of Territory. That the following described territory:

is hereby annexed to the Village of Willow Springs, Cook County, Illinois. 90265507

Section 2. Plat of Annexation. That an accurate map of the aforedescribed territory annexed is attached hereto, marked Exhibit "B" and incorporated herein by reference.

Section 3. Recordation. The Village Attorney is hereby directed to cause a copy of this Ordinance certified by the Village Clerk as a correct copy, together with the original of the Exhibit "B" Plat of Annexation, and an Affidavit certifying that a proper written notification was sent by certified mail, return receipt requested, postage prepaid to each of the Trustees of the Pleasantview Fire Protection District, the Lyons Township Highway Commissioner and the Board of Town Trustees of Lyons Township, to be recorded with the Recorder of Deeds of Cook County, Illinois, in accordance with State statutes.

Section 4. Reporting. The Village Clerk shall report this annexation by delivering a copy of this Ordinance certified by the Village Clerk as correct, by registered or certified mail to the Election Authorities of the State of Illinois and County of Cook and the Clerk of Cook County, Illinois, and to the Chited States Post Office Branches serving the territory annexed within thirty (30) days of the pass of this Ordinance, as required by State statute.

Section 5. Effective Date, Publication. This Ordinance shall become and be effective immediately upon its passage, approval and publication of the manner provided by law, it is ordered that publication of this Ordinance be made by
