Therefore, in consideration of the premises and the mutual promises and agreements herein fter made by and between the parties hereto, the said pricies do hereby mutually promise and agree as follows:

- The principal balance outstanding as of August 31, 1989 is ONE MILLION THREE HUNDRED TROUSAND AND 00/100S (\$1,300,000.00) DOLLARS
- The due date of August 31, 1989 is hereby extended to February 27, 1990.

And the said parties hereto further mutually agree that all provisions, stipulations, powers and covenants in seld Note and in the Mortgage contained, as modified by said Extension Agreement, shall stand and remain unchanged and the full force and effect for and during said extended period, except only as the same are herein and hereby specifically varied or amended; and further that in the event of a failure to pay the same principal sum of \$1,300,000.00 or so much as is here outstanding as herein provided, or to keep, fulfill or perform any or all of the covenants and agreements contained in said Mortgage, then the whole of said principal sum shall, at the election of the holder of said Note, become at once, without notice, due and payable and may be collected together with all accrued interest thereon, in the same manner as if said extension had not been granted, anything hereinbefore contained to the contrary notwithstanding.
