The South Line of Lot 9, also being the North Line of Lot 10 is shown as 152.86 feet, and should be 152.70 feet,

The South Line of Lot 10 is shown as 128.87 feet, and should be 127.02 feet,

The North Line of Lot 11 is shown as 112.16 feet and should be 111.06 feet,

The South Line of Lot 11, also being the North Line of Lot 12 is shown as 123.70 feet and should be 121.73 feet,

The West Line of Lot 11 is shown as 78.11 feet and should be 76.21 feet,

The South Line of Lot 12 is shown as 152.48 feet and should be 119.76 feet.

The West Line of Lot 12 is shown as 53.30 feet and should be 63.53 feet,

The North Line of Lot 13 is shown as 152.48 feet and should be 151.76 feet,

The East Line of Lot 13 is shown as 66.65 feet and should be 67.00 feet to a point of curve, thence 2.66 feet along a chord,

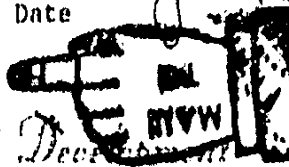
The East Line of Lot 14 is shown as 131.41 feet and should be 139.64 feet,
