SIXTH AMENDMENT TO DECLARATION OF CONDOMINIUM

1. Terms. If not otherwise defined herein, the terms used herein shall have the meanings set forth in the Declaration.
2. Added Property. The following described real estate, which is the additional parcel, is hereby annexed and added to the parcel of the Act and of the Declaration as added property:

NOW, THEREFORE, as the record owner of the real estate herein after described, pursuant to the power reserved in the Declaration to the Declarant and for the purpose above set forth, Declarant hereby amends the Declaration as follows:
B. In Article XII of the Declaration, the Declarant reserved the right and power to annex, add, submit and subject to the provisions of the Act and of the Declaration any part or all of the additional parcel (the "Additional Parcel") as described in Exhibit C to the Declaration, at any time prior to October 27, 1997. Declarant now desires to exercise this power and powers provided in Article XII of the Declaration to annex, add, submit and subject certain real estate located within the Additional Parcel and owned by Declarant, to the provisions of the Act and of the Declaration.

A. Declarant has executed and recorded the Declaration of Condominium Ownership and Restrictions, Restrictions and Covenants for the Silverlake Condominium (the "Declaration") on October 27, 1987 as Document Number 87 579420. The Declaration affects the following described real estate located in the Village of Orland Park, County of Cook and State of Illinois:
Unit 1-A, 1-B, 1-C & 1-D as delineated on the plat of survey of the following described parcel of real estate:
Parcel 1 in Silverlake Condominium, a Planned Unit Development, of part of the SE 1/4 of Section 10, Township 36 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois.

6. Conveyance of Additional Common Elements. The Added Common Elements contained in the Added Property are hereby granted and conveyed to the Owners subject to the provisions of the Act and the Declaration.

5. Consent. All Owners, by the Declarant, their attorney-in-fact, hereby consent to this Amendment to the Declaration, pursuant to the powers and provisions set forth in Article XII of the Declaration.

4. Amendment of Exhibit B. Exhibit B of the Declaration is hereby amended by substituting therefor the Exhibit B which is attached here. The percentage interest in the common elements appurtenant to the units (including existing units and added units) are hereby shifted and reallocated as set forth in Exhibit B attached hereto.

3. Amendment of Exhibit A. Exhibit A of the Declaration is hereby amended by adding thereto Exhibit A-11 (parcel 11) which is attached hereto.

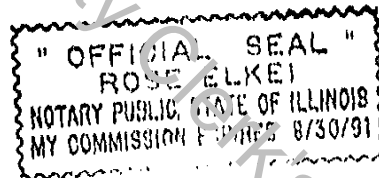
