Recording of such Amended Declaration shall fortify set forth in such Amended Declaration percentages set forth in such Amended Declaration which percentages shall affect all easements to be recorded effective on the recording of such Amended Declaration, and together with all other easements set forth in the recording of such Amended Declaration, in the manner set forth in the recording of such Amended Declaration.
