- That water service was furnished to herein described property by the Claiment, 1) at the rate as provided by Clapter 185 of the Municipal Code of the City of Chicago.
  - 2) That the quantity of water was approximately 343 thousand cubic feet.
  - 3) That the amount due for water service is \$2353.27.
- 4) That sewer service was furnished to the herein described property by the Claimant, at the rate as provided by Charte; 185.1 of the Municipal Code of the City of Chicago.
  - 5) That the amount due for sewer service is \$1835.55.
  - 6) That the total amount due the Claimant therefore is \$4188.62.
  - 7) That the above amounts became delinquent on MANY 20, 1990.
