THIS INDENTURE, made JUNE 18TH 1990, between

This Trust Deed may not be assumed.

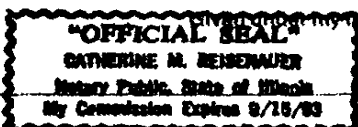
