MORTGAGE AND SECURITY AGREEMENT

THIS INDENTURE is made as of the @coday of June, 1990, by and between (i) HARRIS TRUST AND SAVINGS BANK, not personally but solely as Trustee (the "Trustee") under a Trust Agreement dated May 30, 1990 and known as Trust No. 94741 (hereinafter referred to as the "Trust" or "Mortgagor"), in favor of (ii) BRITEL FUND TRUSTEES LIMITED and POSSFUND CUSTODIAN TRUSTEE LIMITED, each a limited company of the United Kingdon, and POSTEL-LW CORPORATION and BT-LW CORPORATION, each an Illinois corporation (such companies and corporations being herein referred to jointly as "Mortgagee"):

RECITAL:

NOW, THEREFORE, Mortgagor, to secure: (i) the payment of said principal sum of money and all interest, late charges and other indebtedness evidenced by the Note and by any extensions, renewals or refinancings thereof; (ii) the performance and observance of the covenants, terms, conditions and agreements contained in the Note, this Mortgage and the other Loan Documents; and (iii) the reimbursement of Mortgagee for any and all sums expended or advanced by Mortgagee pursuant to any term or provision of or constituting additional indebtedness under or secured by this Mortgage or any of the other Loan Documents, with interest thereon as provided herein or therein; and also in consideration of the sum of TEN DOLLARS (\$10.00) in hand paid, the receipt whereof is hereby acknowledged, does by these presents MORTGAGE, GRANT, ASSIGN, REMISE, RELEASE AND CONVEY unto Mortgagee, its successors and assigns, the real estate and all of its estate, right, title and interest therein situate, legally described in Exhibit A attached hereto and made a part hereof, which together with the property hereinafter described, is referred to herein as the "Premises";

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

1. Title.

Mortgagor represents and covenants that (a) Mortgagor is the holder of the fee simple title to the Premises, free and clear of all liens and encumbrances, except such liens and encumbrances as shall have been expressly approved in writing by Mortgagee, and (b) Mortgagor has legal power and authority to mortgage and convey the Premises.

Payment of Prior Liens, etc.

Morto gor shall (a) promptly repair, restore or rebuild any buildings of improvements now or hereafter on the Premises which may become damaged or be destroyed; (b) keep the Premises in may become damaged or be destroyed; (b) keep the Premises in good condition and repair, without waste, and free from mechanics' liens or other liens or claims for lien, except that Mortgagor shall have the right to contest by appropriate proceedings diligarity prosecuted the validity or amount of any such lien if and only if Mortgagor shall within fifteen (15) days after the filing thereof (1) place a bond with Mortgagee in an amount, form, content and issued by a surety reasonably acceptable to Mortgaget for the payment of any such lien, or (2) cause the title company which has issued the loan policy of title insurance to Mortgage insuring the lien of this Mortgage to issue an endorsement thereto insuring against loss or damage on account of any such lien; (c) immediately pay when due any indebtedness which may be secured by a lien or charge on the Premises superior or inferior to or at parity with the lien hereof (no such superior, inferior or parity lien to be permitted hereunder), and upon request exhibit satisfactory evidence of the discharge of any such lien to Mortgagee; (d) complete within a reasonable time any ouildings or any other complete within a reasonable time any buildings or any other complete within a reasonable time any buildings or any other improvements now or at any time in process of construction upon the Premises; (e) comply with all requirements of law, municipal ordinances and restrictions of record with respect to the Premises and the use and development thereof including without limitation, those relating to building, soning, environmental protection, health, fire and safety; (f) except to the extent expressly permitted under the Loan Agreement, nake no structural or non-structural alterations to the Premises or any buildings or other improvements now or hereafter constructed thereon. or other improvements now or hereafter constructed thereon, without the prior written consent of Mortgagee; (g) auffer or without the prior written consent of Mortgages; (g) and for or permit no change in the general nature of the occupancy of the Premises, without the prior written consent of Mortgages; (h) initiate or acquiesce in no soning reclassification without the prior written consent of Mortgages; (i) pay each item of indebtedness secured by this Mortgage when due according to the terms hereof or of the Note; and (j) duly perform and observe all of the covenants, terms, provisions and agreements herein, in the Note or in the Loan Documents on the part of Mortgagor to be performed and observed. As used in this Paragraph and elsewhere in this Mortgage, the term "indebtedness" shall mean and include the principal sum evidenced by the Note, together and include the principal sum evidenced by the Note, together with all interest thereon and all other amounts payable to Mortgagee thereunder, and all other sums at any time secured by this Mortgage.

3. Payment of Taxes and Assessments.

Mortgagor shall pay before any penalty or interest attaches all general taxes, special taxes, special assessments, water charges, sewer service charges, and all other liens or charges levied or assessed against the Premises, or any interest therein, of any nature whatsoever when due, and shall furnish to Mortgagee duplicate receipts of payment therefor. If any special assessment is permitted by applicable law to be paid in installments, Mortgagor shall have the right to pay such assessment in installments, so long as all such installments are paid prior to the due date thereof. Notwithstanding anything contained herein to the contrary, Mortgagor shall have the right to protest any taxes assessed against the Premises, so long as such protest is conducted in good faith by appropriate legal proceedings diligently prosecuted and Mortgagor shall furnish to the title insurer such security or indemnity as said insurer requires to induce it to issue an endorsement, in form and substance acceptable to Mortgagee, insuring over any exception created by such protest.

4. Tax and Insurance Deposits.

Mortgagor povenants and agrees to deposit with Mortgagee, commencing on the first day of the first month following the first disbursement of proceeds of the Note and on the first day of each month theregiter until the indebtedness secured by this Mortgage is fully raid, a sum equal to one-twelfth (1/12th) of the annual taxes and assessments (general and special) on the Premises, as reasonally determined by Mortgagee. In addition the foregoing, Mortgager shall deposit with Mortgagee, concurrently with the first disbursement of proceeds of the Note, an amount of money, thich together with the aggregate of the monthly deposits to be made pursuant to the preceding sentence as of one month prior to the date on which the total In addition to annual taxes and assessments for the current calendar year become due, shall be sufficient to pay in full the total annual taxes and assessments estimated by Mortgagee to become due and payable with respect to the Premises for the current calendar year. If requested by Mortgages in riting, Mortgagor covenants and agrees to deposit with Mortgages, commencing ten (10) days following such written request and on the first day of each month thereafter until the indebtedness secured by this Mortgage is fully paid, a sum equal to one-twelfth (1/12th) of the annual premiums payable for the insurance required to be maintained in accordance with Paragraph 6 hereof. In addition to the foregoing, if requested by Mortgagee in writing, Mortgagor shall deposit with Mortgagee, within ten (10) days following such written request. an amount of money, when together with the written request, an amount of money, when together with the aggregate deposits to be made pursuant to the preceding sentence as of one month prior to the date on which the next convai insurance premium becomes due, shall be sufficient to pay in full the total annual insurance premium estimated by lortgagee to next become due and payable with respect to the Presions. All deposits made pursuant to this Paragraph are to be held without any allowance of interest and are to be used for the payment of taxes and assessments (general and special) and insurance premiums, respectively, on the Premises next due and payable when they become due. Mortgages may, at its option, itself pay such taxes, assessments and insurance premiums when the same become due and payable (upon submission of appropriate bills therefor from Mortgagor) or shall release sufficient funds to Mortgagor for payment of such taxes, assessments and insurance premiums. If the funds so deposited are insufficient to pay any such taxes, assessments (general or special) and

premiums for any year when the same shall become due and payable, Mortgagor shall within ten (10) days after receipt of demand therefor, deposit additional funds as may be necessary to pay such taxes, assessments (general and special) and premiums in full. If the funds so deposited exceed the amount required to pay such taxes, assessments (general and special) and premiums for any year, the excess shall be applied on a subsequent deposit or deposits. Said deposits need not be kept separate and apart from any other funds of Mortgagee.

5. Mortgagee's Interest In and Use of Deposits.

Upon the occurrence of an Event of Default, Mortgagee may at its option, without being required so to do, apply any monies at the time on deposit pursuant to Paragraph 4 hereof, on any of Mortgagor's obligations herein or in the Note contained, in such order and manner as Mortgagee may elect. When the indebtedness secured hereby has been fully paid, any remaining deposits shall be paid to Mortgagor. Such deposits are hereby pledged as additional security for the indebtedness hereunder and shall be irrevocably applied by Mortgagee for the purposes for which made hereunder and shall not be subject to the direction or control of Mortgager, provided, however, that Mortgagee shall not be liable for any failure to apply to the payment of taxes, assessments and insurance premiums any amount so deposited unless Mortgager, while not in default hereunder, shall have requested Mortgagee in writing to make application of such funds to the payment of which they were deposited, accompanied by the bills for such taxes assessments and insurance premiums. Mortgagee shall not be liable for any act or omission taken in good faith, in the absence of negligence or pursuant to the instruction of any party.

6. Insurance.

Mortgagor shall at all times comply in all respects with the provisions regarding insurance as are contained in Section 4.3 of the Loan Agreement.

7. Condemnation.

If all or any part of the Premises are damaged, taken or acquired, either temporarily or permanently, in any condemnation proceeding, or by exercise of the right of minent domain, the amount of any award or other payment for such taking or damages made in consideration thereof, to the extent of the full amount of the remaining unpaid indebtedness secured by this instrument, is hereby assigned to Mortgagee, who is empowered to collect and receive the same and to give proper receipts therefor in the name of Mortgager and the same shall be paid forthwith to Mortgagee, who shall release any such award or monio, so received or apply the same in whole or in part, after the payment of all of its expenses, including costs and attorneys' fees, to the restoration or repair of the property damaged as provided in Paragraph 22 hereof, if in the reasonable judgment of Mortgagee the property can be restored or repaired to the condition existing immediately prior to the taking. If in the reasonable judgment of Mortgages the said property cannot be restored or repaired to the condition existing immediately prior to the taking, then such award or monies received after the payment of expenses of Mortgages as aforesaid shall be applied on account of the unpaid principal balance is then due and payable and, at any time from and after the taking, upon thirty (30) days prior written notice to Mortgager, Mortgages may

declare the whole of the indebtedness hereby secured to be due and payable. Furthermore, in the event such award or monies so received shall exceed the cost of restoration or repair of the property and expenses of Mortgagee as aforesaid, then such excess monies shall be applied on account of the unpaid principal balance of the Note, irrespective of whether such principal balance is then due and payable. Any application to the unpaid principal balance of the Note pursuant to this Paragraph 7 shall not extend the due date or reduce the amount of the principal and interest installments required to be paid under the Note.

8. Stamp Tax.

If, by the laws of the United States of America, or of any state or political subdivision having jurisdiction over Mortgagor, any tax is due or becomes due in respect of the execution and delivery of this Mortgage or the issuance of the Note hereby secured, Mortgagor covenants and agrees to pay such tax in the manner required by any such law. Mortgagor further covenants to reimburse Mortgagee for any sums which Mortgagee may expend by reason of the imposition of any tax on the issuance of the Note secured hereby. Notwithstanding the foregoing, Mortgager shall not be required to pay any income or franchise taxes of Mortgagee.

9. Observancy of Lease Assignment.

As additional security for the payment of the Note and for the faithful performings of the terms and conditions contained herein, Mortgagor and Mortgagor's beneficiary, as lessor, have assigned to Mortgagee the entire lessor's right, title and interest in and to all lessos and subleases (including all extensions and renewals thereof) which now or hereafter affect all or any portion of the Frezises and in and to all rents, issues, income and profits of or from all or any portion of the Premises pursuant to the Assignment of Rents and Lesses of even date herewith. Mortgagor agrees to deliver to Mortgagee, within five (5) days after receipt by Mortgagor or Mortgagor's beneficiary, all security deposits paid to Mortgagor or Mortgagor's beneficiary under all such lesses and subleases, and to the extent Mortgagor or Mortgagor's beneficiary is holding any such security deposits as of the date hereof, Mortgagor shall deliver such amounts to Mortgagee concurrently with the delivery of this Mortgage.

Mortgagor shall not, without Mortgagee's prior written consent, (a) enter into any lease of all or any portion of the Premises, (b) execute an assignment or pledge of any rents and/or any leases affecting all or any portion of one Premises; or (c) accept any prepayment of any installment of any rents more than thirty (30) days before the due date of such installment, other than security and other deposits.

Nothing in this Mortgage or in any other documents relating to the loan secured hereby shall be construed to obligate Mortgagee, expressly or by implication, to perform any of the covenants of Mortgager as lessor under any of the leases assigned to Mortgagee or to pay any sum of money or damages therein provided to be paid by the lessor (except that Mortgagee shall be responsible for the return of security deposits to tenants under the leases in accordance with the terms and provisions of the leases, but only to the extent that Mortgagee

has actually received any such security deposits), each and all of which covenants and payments Mortgagor agrees to perform and pay.

In the event of the enforcement by Mortgagee of the remedies provided for by law or by this Mortgage, the lessee under each lease affecting all or any portion of the Premises shall, at the option of Mortgagee, attorn to any person succeeding to the interest of Mortgagor as a result of such enforcement and shall recognize such successor in interest as lessor under such Lease without change in the terms or other provisions thereof; provided, however, that such successor in interest shall not be bound by any payment of rent or additional rent for more than one month in advance or any amendment or modification to any lease made without the consent of Mortgagee or such successor in interest. Each lessee, upon request by such successor in interest, shall execute and deliver an instrument or instruments confirming such attornment.

Mortgages shall have the option to declare this Mortgage (after the expiration of the cure period expressly provided for in Paragraph 14(b) below) in default because of a material default of the lessor in any lease affecting all or any portion of the Premizes, whether or not such default is cured by Mortgages pursuant to the right granted herein. It is covenanted and agreed that a default remaining uncured after the expiration of any applicable cure periods expressly provided for under the Assignment of Rents and Leases referred to in the first grammatical paragraph of this Paragraph 9 shall constitute an Event of Default hereunder on account of which the whole of the indebtedness secured hereby shall at once, at the option of Mortgages, become immediately due and payable without notice to Mortgagor.

10. Effect of Extension, of Time.

If the payment of said indubtedness or any part thereof be extended or varied or if any part of any security for the payment of the indebtedness be released, all persons now or at any time hereafter liable therefor, or interested in the Premises or having an interest in Mercgagor or in the beneficiary of Mortgagor, shall be held to assent to such extension, variation or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by Mortgagee, notwithstanding such extension, variation or release.

11. Effect of Changes in Laws Regarding Tavation.

In the event of the enactment after this date of any law of the state in which the Premises are located deducting from the value of the land for the purpose of taxation any lier thereon, or imposing upon Mortgagee the payment of the whole or any part of the taxes or assessments or charges or liens herein required to be paid by Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or Mortgagee's interest in the Premises, or the manner of collection of taxes, so as to affect this Mortgage or the indebtedness secured hereby or the holders thereof, then, and in any such event, Mortgagor, upon demand by Mortgagee, shall pay such taxes or assessments, or reimburse Mortgagee therefor; provided, however, that Mortgagor shall not be deemed to be required to pay any income or franchise taxes of Mortgagee. Notwithstanding the foregoing, if in the opinion of counsel for

Mortgagee (a) it might be unlawful to require Mortgagor to make such payment, or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law, then and in such event, Mortgagee may elect, by notice in writing given to Mortgagor, to declare all of the indebtedness secured hereby to be and become due and payable thirty (30) days from the giving of such notice.

12. Mortgagee's Performance of Defaulted Acts and Expenses Incurred by Mortgagee.

Mortgagee may, but need not, make any payment or perform any act herein required of Mortgagor in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting the Premises or consent to any tax or assement or cure any default of Mortgagor in any lease of the Propises. Mortgages may, but shall not be required to, complete construction, furnishing and equipping of any buildings or other improvements now or at any time hereafter on the Premises, and rent, operate and manage the Premises and such buildings and improvements and pay operating costs and expenses, including management fees, of every kind and nature in connection the with, so that the Premises and such buildings and improvements shall be operational and usable for their intended purposes. All monies paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith including reasonable attorneys' fees, and any other monies advanced by Mortgagee in regard to any tax referred to in Paragraph 3 above or to protect the Premises or the lien hereof, shall be so much additional indebtedness secured hereby, and shall accome immediately due and payable without notice and with interest thereon at the Default Rate (as defined in the Loan Agreement). In addition to the foregoing any costs, expenses and fees, including reasonable attorneys fees, incurred by Mortgagee in connection with (a) sustaining the lien of this Mortgage or its priority, (b) protecting and In addition to the foregoing, enforcing any of Mortgagee's rights hareunder, (c) recovering enforcing any of Mortgagee's rights hareunder, (c) recovering any indebtedness secured hereby, (d) any litigation or proceedings affecting the Note, this Mortgage, the Premises or any guaranter of the Note or this Mortgage, including without limitation, bankruptcy and probate proceedings, or (e) preparing for the commencement, defense or participation in any threatened litigation or proceedings, shall be so much additional indebtedness secured hereby, and shall become immediately due and payable without notice and with interest thereon at the Default Rate. The interest accruing under this Paragraph 12 shall be immediately due and payable by Mortgagor co Mortgagee, and shall be additional indebtedness evidenced by the Note and secured by this Mortgage. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to it on account of secured by this Mortgage. Inaction of Mortgages shell never be considered as a waiver of any right accruing to it on account of any default on the part of Mortgagor. Should the proceeds of the Note or any part thereof, or any amount paid out or olvanced by Mortgages hersunder, or pursuant to any agreement executed by Mortgagor in connection with the loan evidenced by the Note, be used directly or indirectly to pay off, discharge or satisfy, in whole or in part, any lien or encumbrance upon the Premises or any part thereof, then as additional security hereunder, Mortgagee shall be subrogated to any and all rights, equal or superior titles, liens and equities, owned or claimed by any owner or holder of said outstanding liens, charges and indebtedness, however remote, regardless of whether said liens, charges and indebtedness are acquired by assignment or have been

released of record by the holder thereof upon payment. Notwithstanding anything contained herein to the contrary, in no event shall the indebtedness secured by this Mortgage exceed an amount equal to Five Hundred Million and No/100 Dollars (\$500,000,000.00).

13. Mortgagee's Reliance on Tax Bills and Claims for Liens.

Mortgagee in making any payment hereby authorised: (a) relating to taxes and assessments, may do so according to any bill, statement or estimate produced from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof; or (b) for the purchase, discharge, compromise or settlement of any other prior lien, may do so without inquiry as to the validity or amount of any claim for lien which may be asserted, provided that if no Event of Default then exists hereunder Mortgagee shall give to Mortgager ten (10) days' prior written notice thereof.

14. Moreleration of Indebtedness in Event of Default.

Each of the following shall constitute an "Event of Default" for purposes of this Mortgage:

- (a) Mortgagor or Mortgagor's beneficiary fails to pay within five (5) days after the date when due (1) any installment or principal or interest payable pursuant to the Note, or (11) any other amount payable pursuant to the Note, this Mortgage or any of the other Loan Documents;
- Mortgagor or Mortgagor's beneficiary fails to promptly comply with, rerform or cause to be performed any obligation or observe any condition, covenant, term, agreement or provision required to be performed or observed by Mortgagor under (i) the Note, (ii) this Mortgage, (iii) the Loan Agreement (the "Lean Agreement") of even date herewith among Mortgagor, Mortgagor's beneficiary and Mortgagee, (iv) the Assignment of Rents and Leases of even date herewith made by Mortgagor and Mortgagor's beneficiary to Mortgagee, (v) the Combined Sepurity Agreement and Collateral Assignment of Beneficial Interest in Land Trust of even date herewith made by Mortgagor's beneficiary to Mortgagee, (vi) the Security Agreement (Chattel Mortgage) of even date herewith made by Mortgagor and Mortgagor's beneficiary to Mortgagee, (vii) the Assignment of Licenses, Permits and Contracts of even date herewith made by Mortgagor and Mortgagor's beneficiary to Hortgages, and (viii) any other document or instrument evidencing or securing the Note or delivered to induce Mortrages to disburse the proceeds thereof (the documents described in sections (ii) through (viii) above, both inclusive, being hereinafter collectively referred to as the "Loan Documents") (and not constituting an Event of Default under any other provision of this Paragraph 14); provided however, that unless the continued operation or safety of the Premises, or the priority, validity or enforceability of the lien created by this Mortgage or any of the other Loan Documents, or the value of the Premises is impaired, threatened or jeopardized, Mortgagor shall have a period of thirty (30) days after written notice of any such failure of performance or observance to cure the same and an Event of Default shall not be deemed to exist during said thirty (30) day period, except that if such failure is not susceptible of being cured within such thirty (30) day period, Mortgagor

shall have an additional reasonable period of time (in no event to exceed sixty (60) additional days) to cure such failure so long as Mortgagor has commenced curing such failure within the original thirty (30) day period and thereafter actively, diligently and continuously pursues such cure;

- (c) The existence of any inaccuracy or untruth in any material respect in any representation, covenant or warranty contained in this Mortgage or any of the other Loan Documents or of any statement or certification as to facts delivered to Mortgagee by or on behalf of Mortgagor or Mortgagor's beneficiary;
- (d) Any Bankruptcy Party (as defined in the Loan Agreement) files a voluntary petition in bankruptcy, or is adjudicated a bankrupt or insolvent, or files any petition or answer seeking any reorganization, arrangement, composition, readjustment, liquidation, dissolution or similar relief under any present or future Federal, state, or other statute or law, or seeks or consents to, or acquicates in the appointment of a receiver, trustee or similar officer of any Bankruptcy Party or of all or any substantial portion of the property of any Bankruptcy Party, or admits in writing its inability to pay its debts as they mature, or takes an assignment for the benefit of creditors, subject to the cure rights expressly set forth in Section 6.1.4 of the Loan Agreement;
- (e) The commencement of any involuntary petition in bankruptcy against any Bankruptcy Party, or the institution against any Bankruptcy Party of any reorganization, arrangement, composition, readjustment, dissolution, liquidation or similar proceedings under any present or future Federal, state or other statute or law, or the appointment of a receiver, trustee or similar officer of any Bankruptcy Party or of all or any substantial portion of the property of any Bankruptcy Party, which shall remain undismissed or undischarged for a period of sixty (60) days, subject to the cure rights expressly set forth in Section 6.1.5 of the Loan Agreement; or
- (f) Any sale, transfer, lease, assignment, conveyance, financing, lien or encumbrance made in violation of Paragraph 27 of this Mortgage.

If an Event of Default occurs, Mortgages may, at its option, declare the whole of the indebtedness hereby secured to be immediately due and payable without notice to Morigagor, with interest thereon from the date of such Event of Default at the Default Rate. If while any insurance proceeds or configuration awards are being held by Mortgages to reimburse Mortgagor for the cost of rebuilding or restoration of buildings or isprovements on the Premises, as set forth in Paragraph 22 hereof, Mortgages shall have the right to accelerate the indebtedness secured hereby, then and in such event, Mortgages shall be untitled to apply all such insurance proceeds and condemnation awards then held by it in reduction of the indebtedness hereby secured and any excess held by it over the amount of indebtedness then due hereunder shall be returned to Mortgagor or any party entitled thereto without interest.

15. Foreclosure; Expense of Litigation.

When the indebtedness hereby secured, or any part thereof, shall become due, whether by acceleration or otherwise, Mortgagee shall have the right to foreclose the lien hereof for such indebtedness or part thereof and/or exercise any right, power or remedy provided in this Mortgage or any of the other Loan Documents. It is further agreed that if default be made in the payment of any part of the secured indebtedness as an alternative to the right of foreclosure for the full secured indebtedness after acceleration thereof, Mortgages shall have the right to institute partial foreclosure proceedings with respect to the portion of said indebtedness so in default, as under a full foreclosure, and without declaring the entire secured indebtedness due (such proceeding being hereinafter referred to as a "partial foreclosure"), and provided that if foreclosure sale is made because of default of a part of the secured indebtedness, such sale may be made subject to the continuing lien of this Mortgage for the unmatured part of the secured indebtedness; and it is agreed that such sale pursuent to a partial foreclosure, if so made, shall not in any manner affect the unmatured part of the secured indebtedness, but as to such unmatured part this Mortgage, the lien hereof shall remain in full force and effect just as though no foreclosure sale had been made under the provisions of this Paragraph. Notwithstanding the filing of any partial foreclosure or entry of a decree of sale therein, Mortgages may elect at any time prior to a foreclosure sale pursuant to such decree, to discontinue such partial foreclosure and to accelerate the secured indebtedness by reason of any uncired default or defaults upon which such partial foreclosure was predicated or by reason of any other defaults, and proceed with full foreclosure proceedings. It is further agreed that several foreclosure sales may be made pursuant to partial foreclosures without exhausting the right of full or partial foreclosure rale for any unmatured part of the secured indebtedness, it being the purpose to provide for a partial foreclosure sale of the decured indebtedness without exhausting the power to foreclose and to sell the Premises pursuant to any such partial forestosure for any other part of the secured indebtedness whether mattered at the time or subsequently maturing, and without exhausting any right of acceleration and full foreclosure. In the event of a foreclosure sale, Mortgages is hereby authorised, without the consent of Mortgagor, to assign any and sli insurance policies to the purchaser at such sale, or to take auch other steps as Mortgagee may deem advisable to cause the interest of such purchaser to be protected by any of the said insurance policies.

In any suit to foreclose or partially foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgages for attorneys' fees, appraisers' fees, outleys for documentary and expert evidence, stenographers' charges, publication costs, and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches and examinations, title insurance policies, and similar data and assurances with respect to the title as Mortgages may deem reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the Premises. All expenditures and expenses of the nature in this paragraph mentioned and such expenses and fees as may be incurred in the enforcement of Mortgagor's obligations hereunder, the protection of said

Premises and the maintenance of the lien of this Mortgage, including the fees of any attorney employed by Mortgagee in any litigation or proceeding affecting this Mortgage, the Note, or the Premises, including probate and bankruptcy proceedings, or in preparations for the commencement or defense of any proceeding or threatened suit or proceeding shall be immediately due and payable by Mortgagor, with interest thereon at the Default Rate and shall be secured by this Mortgage.

16. Application of Proceeds of Foreclosure Sale.

The proceeds of any foreclosure (or partial foreclosure) sale of the Premises shall be distributed and applied in the following order of priority: first, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in Paragraph 15 hereof; second, all other items which may under the terms hereof constitute secured indevelness additional to that evidenced by the Note, with interest thereon as herein provided and all principal and interest remaining unpaid on the Note; and third, any surplus to Mortgagor its successors or assigns, as their rights may appear.

17. Appointment of Receiver.

Upon, or at any time after the filing of a complaint to foreclose (or partially foreclose) this Mortgage, the court in which such complaint is filed may appoint a receiver of the Premises. Such appointment may be made either before or after sale, without notice without regard to the solvency or insolvency of Mortgago. It the time of application for such receiver and without rejoint to the then value of the Premises or whether the same shall be then occupied as a homestead or not and Mortgagee hereunder or any holder of the Note may be appointed as such receiver. Such receiver shall have power to collect the rents, issues and profits of the Premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency during the full statutory period of redemption, whether there be redemption or not as well as during any further times when Mortgagor, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, peasession, control, management and operation of the Premises during the whole of said period. The court from time to time may authorize the receiver to apply the net income in his hand, in payment in whole or in part of: (a) the indebtedness secured hereby, or by any decree foreclosing this Mortgage, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; and (b) the deficiency in case of a sale and deficiency.

18. Mortgagee's Right of Possession in Case of Default.

In any case in which under the provisions of this Mortgage Mortgagee has a right to institute foreclosure proceedings, Mortgager shall forthwith and upon demand of Mortgagee, surrender to Mortgagee, and Mortgagee shall be entitled to take, actual possession of the Premises or any part thereof personally, or by its agents or attorneys, as for condition broken. Mortgagee's rights and remedies under this Paragraph 18 shall be effective whether before or after the whole principal sum secured hereby is declared to be immediately due and payable hereunder, or whether before or after the institution of legal

proceedings to foreclose the lien hereof or before or after sale thereunder. In the event Mortgagee is entitled to take possession of the Premises, Mortgagee in its discretion may, with or without force and with or without process of law, enter upon and take and maintain possession of all or any part of said Premises, together with all documents, books, records, papers and accounts of Mortgagor or then owner of the Premises relating thereto, and may exclude Mortgagor, Mortgagor's beneficiary, or their respective employees, agents or servants, wholly therefrom. In such case Mortgagee, under the powers herein granted, may hold, operate, manage and control the Premises and conduct the business, if any, thereof, either personally or by its agents. Mortgagee shall have full power to use such measures, legal or equitable, as in its discretion may be deemed proper or necessary to enforce the payment or security of the avails, rents, issues, and profits of the Premises, including actions for the recovery of rent, actions, in forcible detainer and actions in distress for rent. Mortgagee shall have full power:

- (a) to cancel or terminate any lease or sublease for any same or on any ground which would entitle Mortgagor to cancel the same;
- (b) to elect to disaffirm any lease or sublease which is then supordinate to the lien hereof;
- (c) to extend or modify any then existing leases and to enter new leaves, which extensions, modifications and leases may provide for terms to expire, or for options to lessees to extend or renew terms to expire, beyond the maturity date of the indebtedness secured hereby and beyond the date of the issuence of a deed or deeds to a purchaser or purchasers at a foreclosure sale, it being understood and agreed that any such leaves, and the options or other such provisions to be contained therein, shall be binding upon Mortgagor and all persons whose interests in the Premises are subject to the lien hereof and upon the purchaser or purchasers at any foreclosure fole, notwithstanding any redemption from sale, discharge of the mortgage indebtedness, satisfaction of any foreclosure judgment, or issuance of any certificate of sale or deed to any purchaser;
- (d) to make any repairs, decorating renewals, replacements, alterations, additions, becrements and improvements to the Premises as to it may does judicious;
- (e) to insure and reinsure the same and all risks incidental to Mortgagee's possession, operation and management thereof; and
- (f) to receive all of such avails, rents, issues and profits; hereby granting full power and authority to exercise each and every of the rights, privileges and powers herein granted at any and all times hereafter without notice to Mortgagor.

Mortgages shall not be obligated to perform or discharge, nor does it hereby undertake to perform or discharge, any obligation, duty or liability under any lease. To the extent provided by law, Mortgagor shall and does hereby agree to protect, indemnify, defend and hold Mortgages harmless of and from any and all liability, loss or damage which it may or might incur under said leases or under or by reason of the assignment

thereof and of and from any and all claims and demands whatsoever which may be asserted against it by reason of any alleged obligations or undertakings on its part to perform or discharge any of the terms, covenants or agreements contained in said leases except for such claims and demands as result directly from the negligent or willful actions of Mortgagee. Should Mortgagee incur any such liability, loss or damage under said leases or under or by reason of the assignment thereof, or in the defense of any claims or demands, the amount thereof, including costs, expenses and attorneys' fees, shall be so much additional indebtedness secured hereby, and shall become immediately due and payable without notice and with interest at the Default Rate.

19. Application of Income Received by Mortgagee.

Mortgages, in the exercise of the rights and powers hereinabov conferred upon it, shall have full power to use and apply the avails, rents, issues and profits of the Premises to the payment of or on account of the following, in such order as Mortgages may determine:

- (a) to the payment of the operating expenses of the premises, including cost of management and leasing thereof (which shall include reasonable compensation to Mortgagee and its agent or agents, if management be delegated to an agent or agents, and shall also include lease commissions (but not with respect to the renewal of existing leases unless provided for therein) and other compensation and expenses of seeking and procuring tenants and entering into leases), established claims for damages, if any, and premiums on insurance hereinabove authorised;
- (b) to the payment of taxes and special assessments now due or which may hereafter become due on the Premises;
- (c) to the payment of all repairs, decorating, renewals, replacements, alterations, additions, betterments, and improvements of the Premison, including the cost from time to time of installing or replacing refrigeration and gas or electric stoves therein, and of placing the Premises in such condition as will, in the judgment of Mortgages, make them readily rentable; and
- (d) to the payment of any indebtwiness secured hereby or any deficiency which may result from any foreclosure sale.

20. Rights Cumulative.

Each right, power and remedy herein conferred upon Mortgages is cumulative and in addition to every other right, power or remedy, express or implied, given now or hereafter existing under any of the Loan Documents or any other document given to secure the Note or at law or in equity, and each and every right, power and remedy herein set forth or otherwise so existing may be exercised from time to time as often and in such order as may be deemed expedient by Mortgages, and the exercise or the beginning of the exercise of one right, power or remedy shall not be a waiver of the right to exercise at the same time or thereafter any other right, power or remedy, and no delay or omission of Mortgages in the exercise of any right, power or remedy accruing hereunder or arising otherwise shall impair any such right, power or remedy, or be construed to be a waiver of any default or acquiescence therein.

21. Mortgagee's Right of Inspection.

Mortgagee and/or its representative shall have the right to inspect the Premises at all reasonable times and access thereto shall be permitted for that purpose.

22. Disbursement of Insurance or Eminent Domain Proceeds.

- (a) Before commencing to repair, restore or rebuild following damage to, or destruction of, all or a portion of the Premises, whether by fire or other casualty or by a taking under the power of eminent domain, Mortgagor shall obtain from Mortgagee its approval of all site and building plans and specifications pertaining to such repair, restoration or rebuilding.
- (b) Prior to the payment or application of insurance proceeds or a condemnation or eminent domain award to the repair or restoration of the improvements upon the Premises as provided in Paragraphs 6 and 7 above, Mortgages shall be entitled to evidence of the following:
 - (1) That there is not then a default in any of the terms, covenants and conditions of the Note, this Mortgage or any of the other Loan Documents;
 - (ii) That Mortgages shall first be given reasonably satisfactory proof that the occurrence of such casualty or taking will not result in a default under any lease covering all or any portion of the Premises or permit any tenant thereunder to terminate its lease and that any repair or restoration will be completed prior to the earlies to occur of the maturity date of the Note, or the earliest date on which the improvements to the Premises are required to be completed pursuant to the terms and provisions of the leases covering all or any portion of the Premises;
 - (iii) That Mortgages shell first be given reasonably satisfactory proof that either such improvements have been fully rescored, or that the expenditure of money as may be received from such insurance proceeds or condemnation award will be sufficient to repair, restore or rewild the Premises, free and clear of all liens, claims and encumbrances, except the lien of this Mortgage;
 - (iv) That in the event such insurance proceeds or condemnation award shall be insufficient to repair, restore or rebuild the said improvements, moregagor or its lessee(s) shall deposit with Mortgagee funds equaling such deficiency, which, together with the insurance proceeds or condemnation award, shall be sufficient to restore, repair and rebuild the Premises; and
 - (V) That prior to the disbursement of any such proceeds held by Mortgagee in accordance with the terms of this Paragraph 22 for the cost of any repair, restoration or rebuilding, Mortgagee shall be furnished with a statement of Mortgagor's architect, certifying the extent of the repair and restoration completed to the date thereof, and such repairs, restoration, and rebuilding have been performed to date in conformity with the plans and specifications approved by Mortgagee

and with all statutes, regulations or ordinances (including building and zoning ordinances) affecting the Premises; and Mortgagee shall be furnished with appropriate evidence of payment for labor or materials furnished to the Premises, and total or partial lien waivers substantiating such payments.

- (c) Prior to the payment or application of insurance proceeds or a condemnation award to the repair, restoration or rebuilding of the improvements upon the Premises as provided in Paragraphs 6 and 7 above there shall have been delivered to Mortgagee the following:
 - (i) A waiver of subrogation from any insurer who claims that no liability exists as to Mortgagor or the then owner or other insured under the policy of injurance in question;
 - (ii) Such plans and specifications, such payment and parformance bonds and such insurance, in such amounts, issued by such company or companies and in such focus and substance, as are required by Mortgagee.
- (d) In the event Mortgagor shall fail to commence and diligently pursue restoration, repair or rebuilding of the improvements upon the Premises within a reasonable time, then Mortgages, at his option, and upon not less than thirty (30) days' written notice to Mortgagor, may commence to restore, repair or rebuild the said improvements for or on behalf of Mortgagor, and for such purpose, may perform all necessary acts to accomplish such restoration, repair or rebuilding. In the event insurance proceeds or condemnation award shall exceed the amount necessary to complete the repair, restoration or rebuilding of the improvements upon the Premises, such excess shall be applied on account of the unpaid principal balance of the Note irrespective of whether such balance is then due and payable.
- (e) In the event Mortgagor covarinces the repair or rebuilding of the improvements located on the Premises, but fails to comply with the conditions precedent to the payment or application of insurance proceeds or a condemnation or eminent domain award set forth in this Perigraph 22; or Mortgagor shall fail to restore, repair or rebuild the improvements upon the Premises within a reasonable time, and if Mortgagee does not restore, repair or rebuild the said improvements as provided in subparagraph (d) above; then Mortgagee may, at its option, accelerate the indibtedness evidenced by the Note and apply all or any part of the insurance proceeds or condemnation award against the indebtedness secured hereby.
- 23. Release Upon Payment and Discharge of Mortgagor's Obligations.

Mortgagee shall release this Mortgage and the lien thereof by proper instrument upon payment and discharge of all indebtedness secured hereby, including payment of reasonable expenses incurred by Mortgagee in connection with the execution of such release.

24. Notices.

All notices and other communications hereunder to any party shall be (i) in writing and shall be deemed to have been given and received when served in person or, if mailed, on the third business-day after the day when deposited in the United States mail, by registered or certified mail, postage prepaid, addressed as provided hereinafter, and (ii) addressed:

25. Waiver of Defenses.

No action for the enforcement of the lien or of any provision hereof shall be subject to any defense whice would not be good and available to the party interposing same in an action at law upon the Note hereby secured.

26. Waiver of Rights.

Mortgagor hereby covenants and agrees that to the extent permitted by law, Mortgagor shall not and will not apply for or avail itself of any appraisement, valuation, stay, extension or exemption laws, or any so-called "Moratorium Laws," now existing or hereafter enacted, in order to prevent or hinder the enforcement or foreclosure of this Mortgage, but hereby waives the benefit of such laws. To the extent permitted by law, Mortgagor, for itself and all who may claim through or under it, waives any and all right to have the property and estates

comprising the Premises marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Premises sold as an entirety.

27. Transfer of Premises; Further Encumbrance.

For the purposes of (i) protecting Mortgague's security, both of repayment and of value of the Premises: (ii) giving Mortgague the full benefit of its bargain and contract with Mortgagor and Mortgagor's beneficiary; (iii) allowing Mortgague to raise the interest rate and collect assumption fees; and (iv) keeping the Premises and the beneficial interest free of subordinate financing liens, Mortgagor, Mortgagor's beneficiary and the guarantors of the Note agree that if this paragraph be deemed a restraint on alienation, that it is a reasonable one, and that, except to the extent expressly permitted by the Loan Agreement, lany sale, conveyance, assignment, further encumbrance or other transfer of title to the Premises, the beneficial interest in the Trust or any interest in the Premises or said beneficial interest (whether voluntary or by operation of law), including without limitation, the entering into of an installment agreement for the sale of the Premises or the beneficial interest in the Trust, the placement or granting of liens on all or any part of the Premises or said beneficial interest or the placement or granting of chattel mortgages, conditional sales contracts, financing or security agreements which would be or create a lien on the personal property owned by Mortgagor or Mortgagor's beneficiary and utilized in the operation of the Premises, or the placement or granting of a mortgage commonly known as a "wrap around" mortgage or an improvement loan, without Mortgagee's prior written consent shall be an Event of Default Arreunder. For the purpose of, and without limiting the generality of the preceding sentence, except to the extent expressly permitted by the Loan Agreement, the occurrence at any time of any of the following events shall be deemed to be an unpermitted transfer of title to the Premises and therefore an Event of Default hereunder:

- (A) any sale, conveyance, assignment or other transfer of, or the grant of a security interest in, all or any part of the title to the Premises or the beneficial interest in, or power of direction under, the trust agreement with Mortgagor;
- (B) any sale, conveyance, assignment or other transfer of, or the grant of a security interest in, any interest in Mortgagor's beneficiary; and
- (C) any male, conveyance, assignment or other transfer of, the grant of a security interest in, any share of any corporation which holds an interest in Mortgagor's beneficiary.

Any consent by Mortgagee, or any waiver by Mortgagee of an Event of Default under this paragraph shall not constitute a consent to, or waiver of any right, ramedy or power of Mortgagee upon a subsequent Event of Default under this Paragraph 27. Mortgagor acknowledges that any agreements, liens, charges or encumbrances created in violation of the provisions of this Paragraph 27 shall be void and of no force or effect.

28. Expenses Relating to Note and Mortgage.

Mortgagor will pay all expenses, charges, costs and fees relating to the loan evidenced by the Note and secured by this Mortgage or necessitated by the terms of the Note, this Mortgage or any of the other Loan Documents, including without limitation, Mortgagee's reasonable attorneys' fees in connection with the negotiation, documentation and enforcement of the Note, this Mortgage and the other Loan Documents, all filing, registration or recording fees, all other expenses incident to the execution and acknowledgment of this Mortgage and all federal, state, county and municipal taxes, and other taxes (provided Mortgagor shall not be required to pay any income or franchise taxes of Mortgagee), duties, imposts, assessments and charges arising out of or in connection with the execution and delivery of the Note and this Mortgage. Mortgagor recognises that, during the term of the Mortgage, Mortgagee:

- (a) May be involved in court or administrative proceedings, including, without restricting the foregoing, foreclosure, probate, bankruptcy, creditors' arrangements, insolvency housing authority and pollution control proceedings of any kind, to which Mortgagee shall be a party by reason of the Loan Documents or in which the Loan Documents or the Premises are involved directly or indirectly;
- (b) May make preparations following the occurrence of an Event of Default hereunder for the commencement of any suit for the foreclosure hereof, which may or may not be actually commenced;
- (c) May make preparations following the occurrence of an Event of Default hereunder for, and do work in connection with, Mortgagee's taking possession of and managing the Premises, which event may or may not actually occur;
- (d) May make preparations for and commence other private or public actions to remail an Event of Default hereunder, which other actions may or may not be actually commenced:
- (e) May enter into negotiations with Mortgagor, Mortgagor's beneficiary, any joint venturer of Mortgagor's beneficiary and/or any guarantor of the Note, or any of their respective agents, employees or attorneys, in connection with the existence or curing of any Event of Default hereunder, the sale of the Premises, the assumption of liability for any of the indebtedness represented by the Note or the transfer of the Premises in lieu of foreclosure; or
- (f) May enter into negotiations with Mortgagor, Mortgagor's beneficiary, any joint venturer of Mortgagor's beneficiary and/or any guarantor of the Note, or any of their respective agents, employees or attorneys, pertaining to Mortgagee's approval of actions taken or proposed to be taken by Mortgagor, Mortgagor's beneficiary, any joint venturer of Mortgagor's beneficiary and/or any guarantor of the Note, which approval is required by the terms of this Mortgage.

29. Business Purpose.

33. Waiver of Right of Redemption.

At the written request and direction of Mortgagor's beneficiary and to the full extent permitted by law, Mortgagor hereby voluntarily and knowingly releases and waives any and all rights to retain possession of the Premises after the occurrence of an Event of Default hereunder and any and all rights of reinstatement and redemption from sale under any order or decree of foreclosure, pursuant to rights therein granted, as allowed under Section 125-1601(b) of the Illinois Mortgage Foreclosure Law (Chapter 110, Sections 15-1101 et seg., Illinois Revised Statues), as amended from time to time (the "Act"), and to the full extent permitted by law, hereby voluntarily and knowingly releases and waives the benefits of all present and future valuation, appraisement, homestead, exemption, stay, redemption and moratorium laws under any state or federal law.

34. Subordination of Property Manager's Lien.
