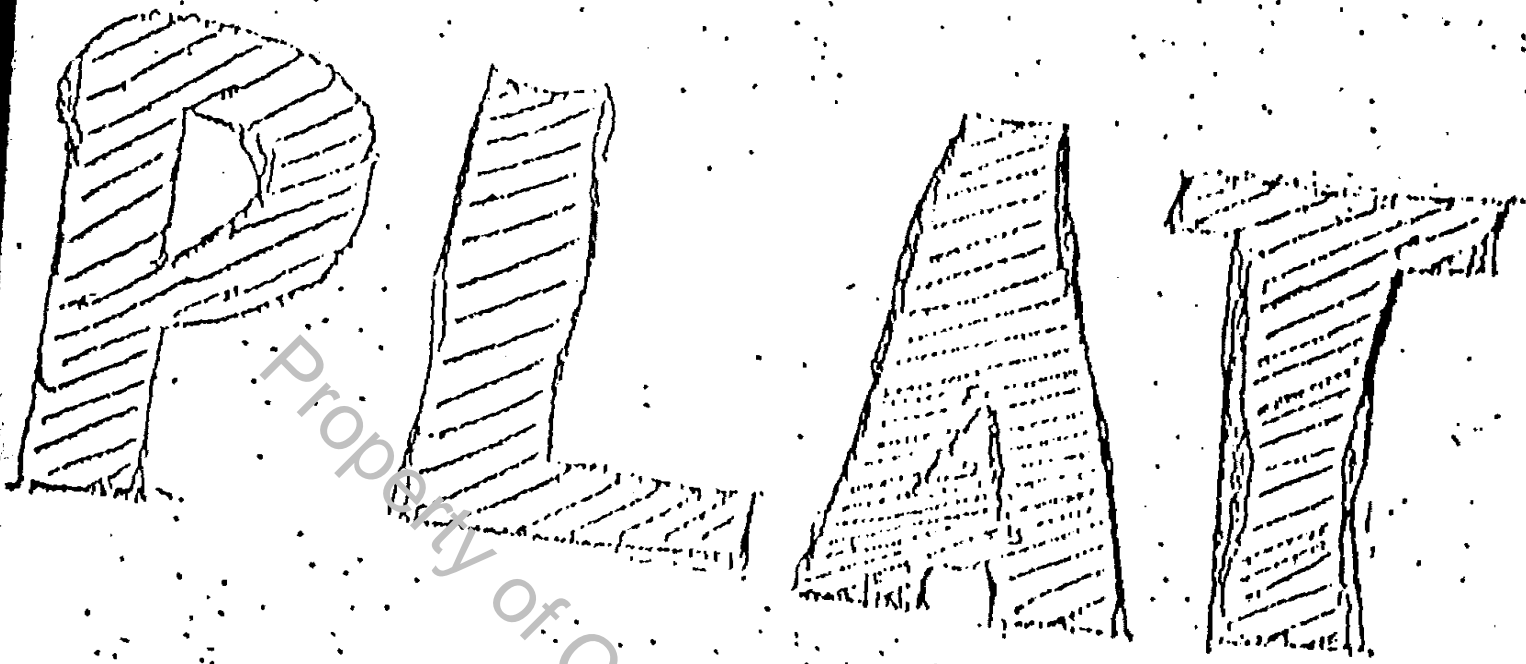

ORDINANCE NO. _____

**AN ORDINANCE ANNEXING PROPERTY
(RPSV, INC.)**

Be It Ordained by the President and Board of Trustees of the Village of Tinley Park, Cook and Will Counties, Illinois, as follows:

Section 1: That this President and Board of Trustees find as follows:

- (a) A Petition has been filed with the Village Clerk and presented in proper form to the President and Board of Trustees of the Village of Tinley Park, requesting that the territory described in Section 2 of this Ordinance be annexed to the Village of Tinley Park, Cook and Will Counties, Illinois;
- (b) The aforesaid Petition is in proper form under oath, signed by all owners of record of all the land within the territory, and also signed by all electors residing within or on said territory;
- (c) That there is no highway adjacent to or located within the aforesaid land which is under the jurisdiction of any Township or its Commissioner of Highways, and therefore no notice of the proposed annexation has been served upon and given to any Township Commissioner of Highways or Board of Town Auditors;
- (d) That the territory described in Section 2 is not located within any fire protection district or public library district, and therefore, no notice need be given to any fire protection district or public library district;
- (e) Such territory described in Section 2 is solely within Cook County and not within the corporate limits of any municipality, but is contiguous to the Village of Tinley Park, Cook and Will Counties, Illinois, a municipality existing under the laws of the State of Illinois.

Section 2: That the following described territory be and the same is hereby annexed to the Village of Tinley Park, Cook and Will Counties, Illinois, together with any highway adjacent thereto as required by law:

That part of the East 1/2 of the Northeast 1/4 of Section 6 North of the Indian Boundary Line lying North of the Interstate 80 Right of Way (except the East 260.00 feet of the North 718.00 feet thereof and except that part of the East 284.00 feet thereof lying South of the center line of a drainage ditch running Southwesterly through said East 1/2 of the Northeast 1/4 of Section 6) all in Township 35 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois.

Section 3: That the Village Clerk is hereby and herewith instructed to record with the Recorder of Deeds of Will County, Illinois, and to file with the County Clerk of Will County, Illinois:

- (a) a copy of this Ordinance certified as correct by the Clerk of said Village of Tinley Park; and
- (b) a plat of the land included in this annexation, as required by law, said plat to be attached to the afore-said certified copy of this Ordinance.

Section 4: That this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
