It is therefore ordered and adjudged:

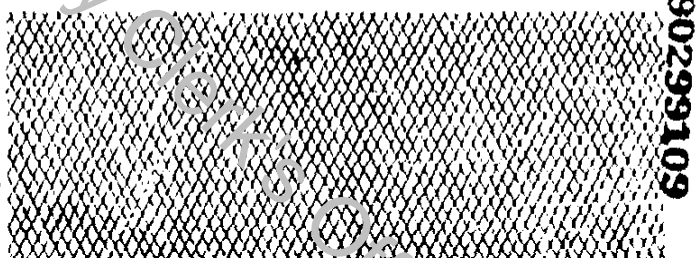
