

#### ORDINANCE NUMBER 1188 (1990)

VILLAGE OF CRESTWOOD

AN ORDINANCE ANNEXING LOT 1 IN BLOCK 5 IN MIDLOTHIAN FIELDS RESUBDIVISION (13700 S. Lawler Avenue)

ARTHONY L. NEVERDOWSKY AND SHERRY L. NEVERDOWSKY, his wife, having filed with the Clerk of the Village of Crestwood, their verified petition, duly executed and sworn to, requesting that the territory described in Section "1" below be annexed to the Village of Crestwood; and

The Village Board (inding that (i) Anthony L.

Neverdowsky and Sherry L. Neverdowsky, his wife, are the
owners of record and holders of all interest in and to the
said territory; (2) Anthony L. Neverdowsky and Sherry L.

Neverdowski are the only electors residing on said
territory; (3) said territory is not within the corporate

Section Two: By reason thereof, the new corporate boundary of the Village of Crestwood shall extend to the far right-of-way of Lawler Avenue bordering upon the territory annexed.

Section Three. That the Village Clerk shall file a plat of annexation describing said property, together with a duly certified copy of this Ordinance, in the office of the Recorder of Cook County, Illinois.

Section Four: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
