ORDINANCE NUMBER 1189 (1990)

VILLAGE OF CRESTWOOD

AN ORDINANCE ANNEXING LOT 7 IN BLOCK 5 IN MIDLOTHIAN FIELDS RESUBDIVISION (13808 Lawler Avenue)

DAVID J. PODOLAK having filed with the Clerk of the Village of Crestwood, his verified petition, duly executed and sworn to requesting that the territory described in Section "1" below be annexed to the Village of Crestwood; and

The Village Board (liding that: (1) David J. Podolak is the owner of record and holder of all interest in and to the said territory; (2) there cra no electors, no registered voters, residing on said territory, (3) said territory is not within the corporate limits of any municipality; and (4) said territory is contiguous to the Village of Crestwood;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Crestwood:

Section One: That the territory legally described as:

Lot 7 in Block 5 in Midlothian Fields, being a Subdivision of the West 1/2 of the Northeast 1/4 of Section 4, Township 36 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois, (Permanent Tax Index Number: 28-04-207-018);
